GENERAL RULES & REGULATIONS

Failure to comply with all rules and regulations forfeits the Permit User’s rights.

- Do not move tables. Do not use staples on picnic tables -- use tape.
- Trash and litter must be placed in receptacles. Permit User is responsible for picking up all sizes of litter. Metallic confetti and helium balloons are prohibited.
- Parking permitted in designated spaces only.
- Do not move pole or boulder barriers. Do not drive or park vehicles beyond barriers.
- Do not disturb vegetation, plant life, trees, shrubs, etc. or gather downed wood in the park.
- Collecting specimens of wildflowers, trees, rocks, etc. is prohibited.
- Day Use Areas are open from 8:00 a.m. until Sunset.
- Check-Out time for overnight stay is 12:00 p.m.
- Wood fires are only permitted in the large BBQ in Group Area #2. Small, stand-alone BBQs are charcoal only.
- Dogs are allowed on leash.
- Amplified sound is prohibited.
- Bounce Houses/Inflatables allowed in Group Areas #1 and #2, by approval and payment of an additional fee.
- Stakes in the ground are not allowed.
- Additional Park Rules are posted at the Campground Check-In area.

The undersigned understands that City programs have priority over all scheduled outside programs/activities, and Monterey Parks Division reserves the right to cancel your program/activity with 48 hours notice.

The undersigned agrees to hold the City of Monterey, its agents and employees, harmless from and to defend same against any claim or judgment for personal injury, damages or any cause of action whatsoever arising from the use of said facility.

The undersigned agrees to be personally responsible for any damage sustained by the facility accruing through the use of said facility by the above named individual/organization (Permit User), and further agrees to conform to all rules and regulations of the facility as stated in the BBQ/Picnic Facility Use Permit and all current State, County and City COVID-19 requirements including the use of face masks, physical distancing, and limitations on group size/capacity.
