

MONTHLY REPORT

MONTEREY POLICE DEPARTMENT



Narrative

- The MPD School Resource Officer (SRO), Community Action Team (CAT) Sergeant, and a Community Services Officer (CSO), attended the La Mesa School Fall Festival. The event was attended by several hundred community members. Kids took pictures on a police motorcycle, explored an MPD patrol vehicle, and 200 light-up toys were distributed for Halloween safety.
- The CAT provided five police station tours, participated in the Trunk-or-Treat event at the Elks Lodge, participated in the La Mesa Safety Fair, assisted with the Coastal Bike Challenge, participated in the Wharf 1 birthday party, and ensured the safety of the Monterey High School homecoming parade attendees.

Narrative Cont...

- An MPD Officer and CSOs participated in a Tip-A-Cop fundraiser for Special Olympics at California Pizza Kitchen with the Monterey County Probation Department and the Monterey County Sheriff's Office.
- Officers responding to a possible heroin overdose and found an unresponsive male. The officers administered NARCAN and the male regained consciousness and survived.
- In May 2018, an MPD Detective investigated a burglary. The detective was able to develop information on the suspect from stolen credit cards. The detective identified both suspects as members of a well-known criminal street gang from Oakland. The detective worked with surrounding agencies to locate and arrest one of the suspects. The suspect was booked into Monterey County Jail pending sentencing for burglary and identify theft with gang enhancements.

Narrative Cont...

- A suspect stole a gun from Hunter's Supply. Detectives identified and arrested the suspect, recovered the gun and 50 rounds of ammo.
- Detectives investigated the sexual assault of a 12 year-old at risk youth. They obtained a \$600K warrant and arrested him outside of Fresno. He admitted to multiple other crimes with juveniles outside of Monterey.
- Detectives arrested a serial burglar and prowler on Casanova
- Detectives gave a presentation on MPD's partnership with the YWCA at a domestic violence conference.
- The CSOs assisted with Active Shooter Training at MPC, Trunk-or-Treat at the Elks Lodge, the La Mesa Safety Fair, Tip-A-Cop, and completed 5 station tours.

Narrative Cont...

- A serial vehicle burglar was identified on video surveillance breaking into a vehicle. An alert officer spotted and arrested the suspect.
- CSOs were conducting an animal abuse investigation and realized the animal's owner was in crisis and needed services. CSOs contacted and coordinated with Monterey County Social Workers to get the elderly woman assistance.

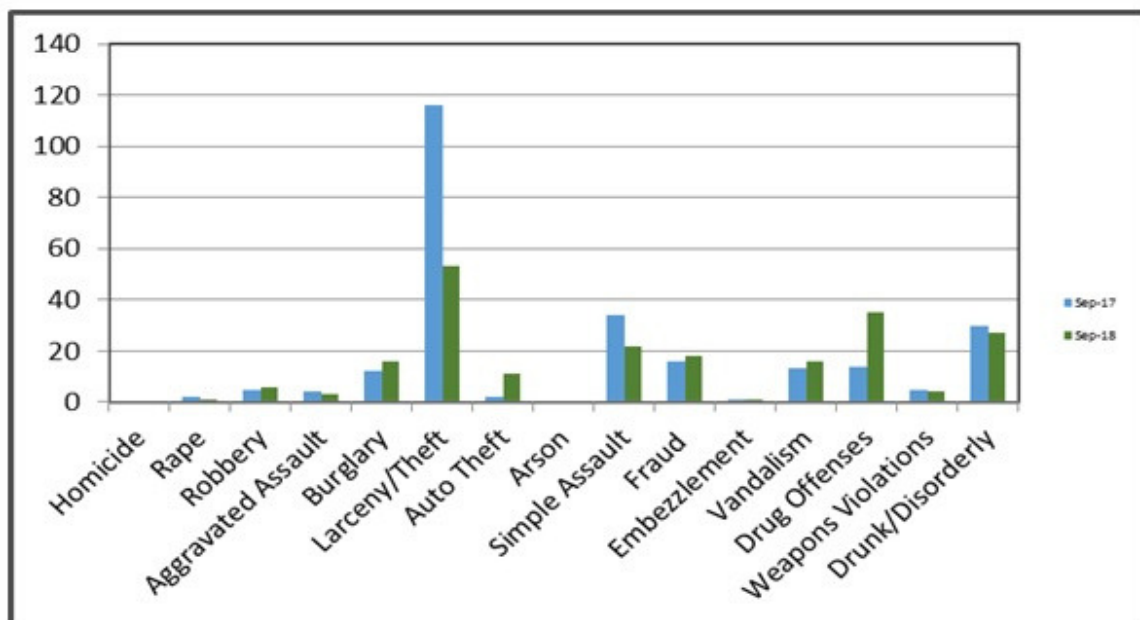


Table A – September 2017 v. September 2018

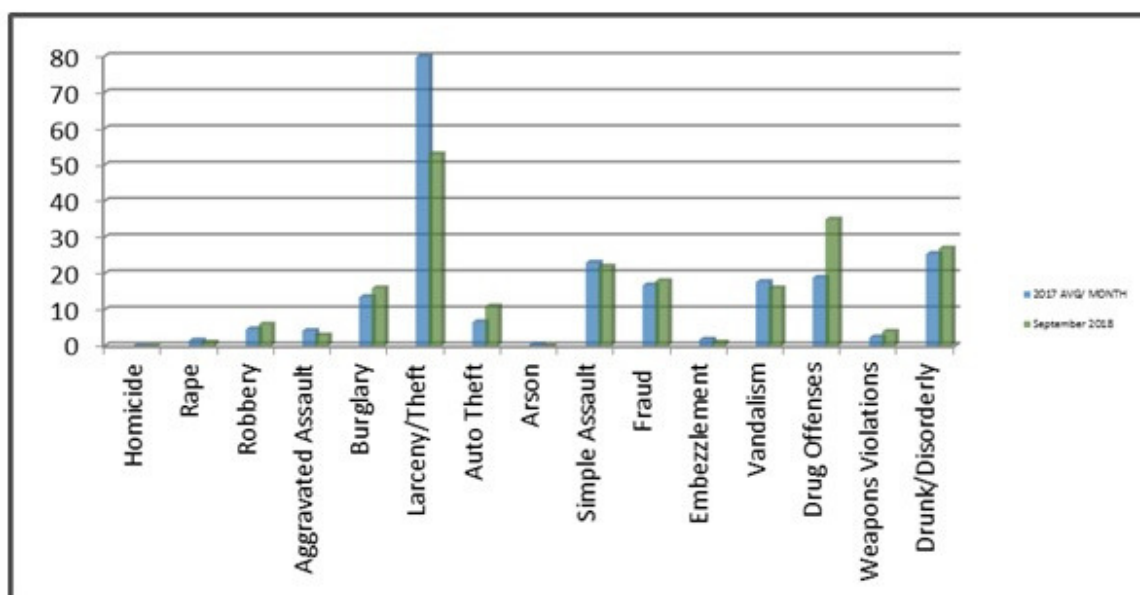


Table B – 2017 Monthly Average v. September 2018
