Narrative

May 25, 2020- The murder of George Floyd by members of the Minneapolis Police Department

- The MPD shares in the sadness and grief surrounding this event and in the outrage surrounding the criminal actions of the police officers involved.
- This event has led to protest, discussion, thought and change.
- The MPD has always attempted to be at the front end of implementing best practices and being responsive to the communities we serve.
- The MPD recognizes and respects the value of all human life and dignity without prejudice to anyone.
- The MPD recognizes that we all have a duty to intercede if we see something wrong.
- The MPD utilizes Body Worn Cameras
- The MPD has a multi-faceted approach to ensuring MPD officers understand and embrace the ethical tenants of being police officers. The MPD adheres to the six pillars that are set out in The President's Task Force on 21st Century Policing (2015)
 - Prior to being hired, MPD officers undergo a rigorous background that includes a psychological evaluation for suitability to be police officers.
 - The MPD has the highest hiring standards and will only hire someone who exemplifies the tenants of desiring to serve with honor, dignity, fairness and respect. This ethos is demanded of all MPD staff.
- This ethical base is reinforced with self-awareness, training, supervision, policy, leadership, internal affairs investigations and if warranted discipline.
- The MPD reinforces expectations with on-going continuous training that includes:
 - Implicit Bias Training
 - Racial Profiling Training
 - Cultural Diversity
 - Procedural Justice Training (Voice/ Neutrality/ Respectful Treatment/ Trustworthiness
 - LGBTQ+ training (through District Attorney's Office)
 - Integrating Communications, Assessment, and Tactics (ICAT/PERF) – De-Escalation critical thinking utilizing classroom and scenario training.
 - Crisis Intervention Training (understanding & communicating with people suffering from mental illness) – facilitated with County Behavioral Health.
- One-Mind Campaign (IACP program to further understanding of persons suffering from mental illness) – facilitated with County Behavioral Health.
- The MPD has implemented contemporary programs such as the Multi-Disciplinary Outreach Team (MDOT) that partners MPD Community Action Team (CAT) Officers with a social worker from CHOMP, an outreach counselor from Interim, a crisis worker from County Behavioral Health, a YWCA domestic violence counselor and a social worker from County Adult Protective Services.
- The MPD was already in compliance with all of the eight points described in former President Obama's "Police Use of Force Project" and changed policy to ban the use of the carotid control hold. The MPD produced a document describing the MPDs use of force policies and practices related to the eight issues.
- The MPD will continue to work with the community to build relationships, seek input and be responsive to what the community desires of its police department.

Narrative

COVID-19

- The MPD continued to adjust to the issues surrounding COVID-19 pandemic.
- The MPD continued to work through understanding, appropriately educating and if needed enforcing the County Shelter In Place (SIP) order. This has been in coordination with the Monterey County District Attorney, Monterey County Health Officer and the City Attorney's Office.
- All MPD sworn returned to work at the MPD campus on May 11. Detectives were working from home to preserve the workforce in the event of a COVID outbreak. All MPD staff returned to work on May 18.
- Some MPD members started voluntarily participating in a COVID-19 study with the Monterey Fire Department.

Patrol

- An MPD Officer observed a suspect looking into a passenger window of a parked vehicle and then walk to another vehicle. The officer ran the license plate of the second vehicle and learned the license plate was stolen. The subject was found to have an active warrant for possession of stolen property from another county.
- Officers responding to an in-progress theft from a vehicle and located and arrested the suspect. The stolen property was recovered and returned to the victim.
- A Monterey police officer observed a subject riding a stolen bicycle and arrested him for possession of stolen property.
- Officers responding to a Shelter-In-Place violation found four adults and a homeowner operating an auto detailing business out of the residence. The officers made contact and subsequently ran the individuals for wants and warrants. Several of the subjects were cited for narcotics violations and false identification to a police officer.
- An MPD Officer arrested a subject for strong-armed robbery and possession of narcotics.
- An MPD Officer detained a subject after recognizing the suspect from a wanted flyer. The suspect was arrested on a warrant for a prior assault with a deadly weapon.

Community Action Team (CAT)

- CAT marked (129) encampments and abated (114). There were (36) at Del Monte/English, (34) at Del Monte Beach, and (21) at Robert's Lake. Officers provided flyers to homeless persons with information regarding services available to them.
- CAT officers walked (202) foot patrol hours and assisted with (5) protests.
- CAT officers provided a new wheelchair to a homeless person whose wheelchair had broken.
- CAT and MDOT coordinated with Whole Person Care to provide case management and medical prescriptions to a homeless couple at Roberts Lake.
- CAT provided cloth masks and hand sanitizer to individuals on the wharf.

Multi-Disciplinary Outreach Team (MDOT)

- MDOT assisted a man with a methamphetamine addiction get into Sun Street Center for rehabilitation.
- MDOT distributed masks and hand sanitizer to individuals in the Transit Plaza.
- MDOT was able to coordinate with Sun Street Center to assist a homeless person suffering from alcoholism into rehabilitation.
- MDOT assisted a recovering substance abuse client with a temporary identification so she could cash her employment check.

Investigations

- Detectives conducted proactive probation searches resulting in (5) arrests, recovery of stolen property and narcotics.
- Detectives identified a suspect who was involved in a burglary from video surveillance. MPD Detectives located and arrested the suspect after several days of surveillance at various locations.
- Santa Cruz Police issued a flyer requesting identification of a suspect from a burglary in which the suspect broke a window to make entry. An MPD detective recognized a suspect and notified Santa Cruz Police as to who the suspect appeared to be.
- Detectives obtained a \$530,000 arrest warrant for a subject who struck a police vehicle and fled the scene. Detectives worked with Salinas PD to locate and arrest the suspect. The suspect was arrested for identify theft and possession of methamphetamine and heroin for sale.

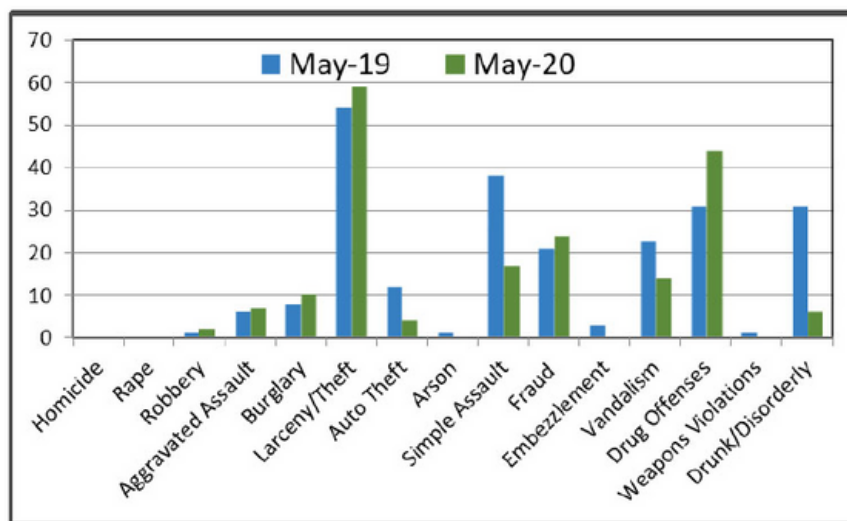

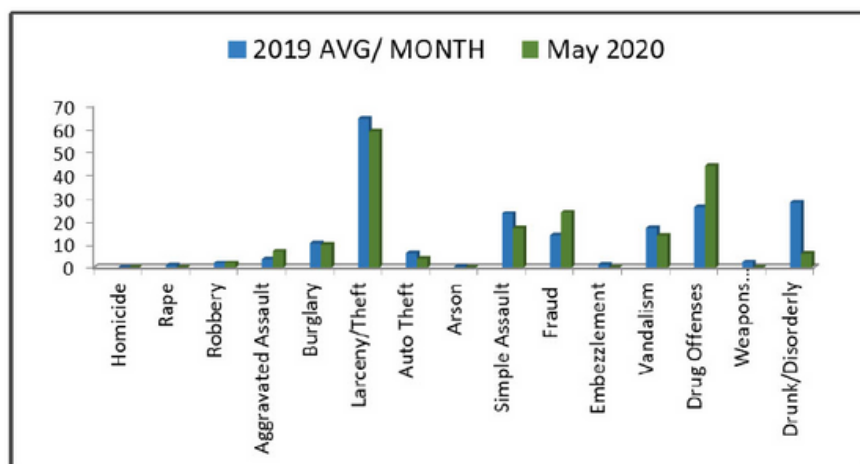
