Narrative

COVID-19

- The MPD continued to address issues surrounding the COVID-19 pandemic.
- The MPD FY 20-21 budget was reduced by 8.2% from the previous fiscal year as a result of projected financial losses to the City due to the COVID-19 Pandemic. The reductions were primarily realized through personnel funding by freezing positions (four sworn, one CSO, one PST, six part-time CSOs) and reducing some operational funding.
- The MPD continues to educate/enforce issues related to the State guidelines surrounding the increase or reduction in restrictions related to the pandemic.
- On June 18, 2020, the state issued guidance that required facemasks for persons in public. On July 2, 2020, the City of Monterey enacted an emergency order requiring face masks in Monterey. While City beaches were restricted from May 08, 2020 to June 6, 2020, the City closed all beaches for the July 4th weekend (07-03-20 to 07-05-20).
- The MPD assigned Community Service Officers (CSO)s to educate persons about the face mask ordinances and pass out masks for persons who did not have them.
- The MPD has worked with Monterey City Code Compliance Officers, City Attorney's Office and District Attorney's Office to ensure businesses and individuals were complying with the State and County COVID-19 guidelines.
- Multiple hotels in Monterey have been housing COVID+ patients to shelter in place. Some of the hotels have been coordinated by Monterey County and others coordinated by the agricultural industry. MPD has responded to some of these hotels for various disturbances and other issues related to persons that have been placed at the hotels.





Narrative

Protests

- On June 2, 2020, a "Black Lives Matter" protest started at Seaside City Hall and included between 1,000 to 2,000 people. After a rally at Seaside City Hall the protesters marched in three groups throughout Seaside and Monterey. One group marched from Seaside into Monterey, along North Fremont, across Highway One, and into Downtown Monterey and along Del Monte Avenue to Seaside City Hall. The MPD utilized all available resources to assist in the safety of the marchers, City traffic and the community. The march was peaceful and all MPD resources were utilized for approximately three hours.
- On June 9, 2020, a "Black Lives Matter" protest started at Monterey City Hall and included between 2,000 to 3,000 people. After a rally at Monterey City Hall the group conducted three marches throughout Monterey in the Downtown area and along Cannery Row and Lighthouse Avenue. After each march the group returned to Monterey City Hall. All available MPD resources (on-duty & off-duty) were called back to work the event. All MPD resources were utilized to assist in the safety of the marchers, City traffic and the community. The MPD worked with peninsula law enforcement agencies, the Monterey County Sheriff's Office, the California Highway Patrol, the Monterey Fire Department, Monterey Public Works and other entities. The event was peaceful and lasted approximately six hours.

Patrol

- The California Highway Patrol (CHP) advised the MPD that a suspect vehicle was last seen fleeing into Monterey after CHP was involved in a vehicle pursuit on Hwy 68. A Monterey police officer located the suspect vehicle and detained the suspect until CHP took the driver into custody for Driving Under the Influence.
- Monterey officers responded to a report of a subject threatening a gas station clerk with a knife. Officers contacted the subject and utilized tactics that included de-escalation techniques. As a result, the suspect put the knife away, however was still armed with a pipe. Officers used equipment and tactics that allowed the subject to be taken into custody without injury to the subject or the officers. The suspect was placed on a mental health hold and transported to CHOMP to be psychologically evaluated.
- MPD Officers responded to a report of a suicidal subject. Officers located the subject and attempted to persuade him to obtain help. The subject threw water on the officers, spit on the officers, kicked at the officers and EMTs prior to being placed in restraints. The subject was transported to CHOMP for psychological evaluation and assistance.
- MPD Officers recovered items that were stolen from a citizen's front porch. The citizens were very appreciative and commended the officers for their interpersonal skills.



Narrative

Patrol Continued

- MPD and other peninsula Officers collaterally assigned to the Monterey Peninsula Regional Special Response Unit (SWAT & Negotiators), responded to a call-out in Pacific Grove. A subject who was on parole was barricaded in a home after threatening to shoot people with an assault rifle. The subject was erratic and it was believed he had utilized illicit drugs. After hours of negotiation, the suspect exited the house and was taken into custody.
- MPD Officers arrested a subject for burglary and located stolen property, stolen mail, stolen credit cards and other property related to multiple criminal cases.
- On June 6, 2020, MPD and other peninsula Officers collaterally assigned to the Monterey Peninsula Regional Special Response Unit (SRU) responded to Ben Lomond in Santa Cruz County after a suspect ambushed and killed a Santa Cruz County Sergeant and injured two other law enforcement officers. The Monterey Peninsula Regional SRU assisted in securing the suspect's residence and most officers assisting worked in excess of twenty-four consecutive hours.
- MPD Officers responded to a subject yelling racial slurs at and assaulting someone. When MPD Officers arrived the suspect had left the scene. Officers were able to identify the suspect utilizing cell phone video taken by the victim. MPD detectives followed-up and after surveilling various locations were able to locate and arrest the suspect the day after the hate crime occurred.
- MPD officers responded to a call of a subject shooting a handgun in a Monterey neighborhood. Officers identified the house the subject was in and employed tactics to attempt to ensure safety for all involved. The officers engaged the suspect in conversation. After a short period of time, the subject charged at the officers with his hands behind his back. As the subject got close to a sergeant, the subject pulled his hands from behind his back and pointed them toward the sergeant. The sergeant was able to determine that the suspect was now unarmed and several officers took the suspect into custody. Officers canvassed the neighborhood to ensure the subject had not injured anyone while discharging his firearm. Officers transported the subject to a hospital for psychiatric evaluation.



Narrative

Community Action Team (CAT)

- CAT marked (99) encampments and abated (74). There were (38) at Del Monte Beach, (12) at the El Estero Boat House, (15) at Don Dahvee Park, (2) at the Old Capital Site and the remaining encampments were at various locations throughout the City. Officers provided flyers to homeless persons with information regarding services available to them.
- CAT officers walked (120) foot patrol hours and assisted with the Black Lives Matter protest.
- CAT conducted outreach with the Veteran Resource Center at the skate park during the homeless feed.
- CAT contacted a woman who was evicted from her hotel room and could not afford housing. CAT interfaced with Community Homeless Solutions who was able to find housing for the woman.

Multi-Disciplinary Outreach Team (MDOT)

- MDOT collaborated with Sun Street to provide treatment for a subject struggling with methamphetamine addiction.
- MDOT collaborated with the Veterans Resource Center to house a chronic transient.

Investigations

- MPD Detectives assisted CSUMB Police with an attempted murder shooting investigation that occurred in that jurisdiction. MPD detectives assisted with the interview of the victim and the eventual identification of the domestic violence suspect.
- Detectives recovered three firearms in June. During the multiple investigations, additional property that was taken during a burglary and evidence of identity theft was recovered.

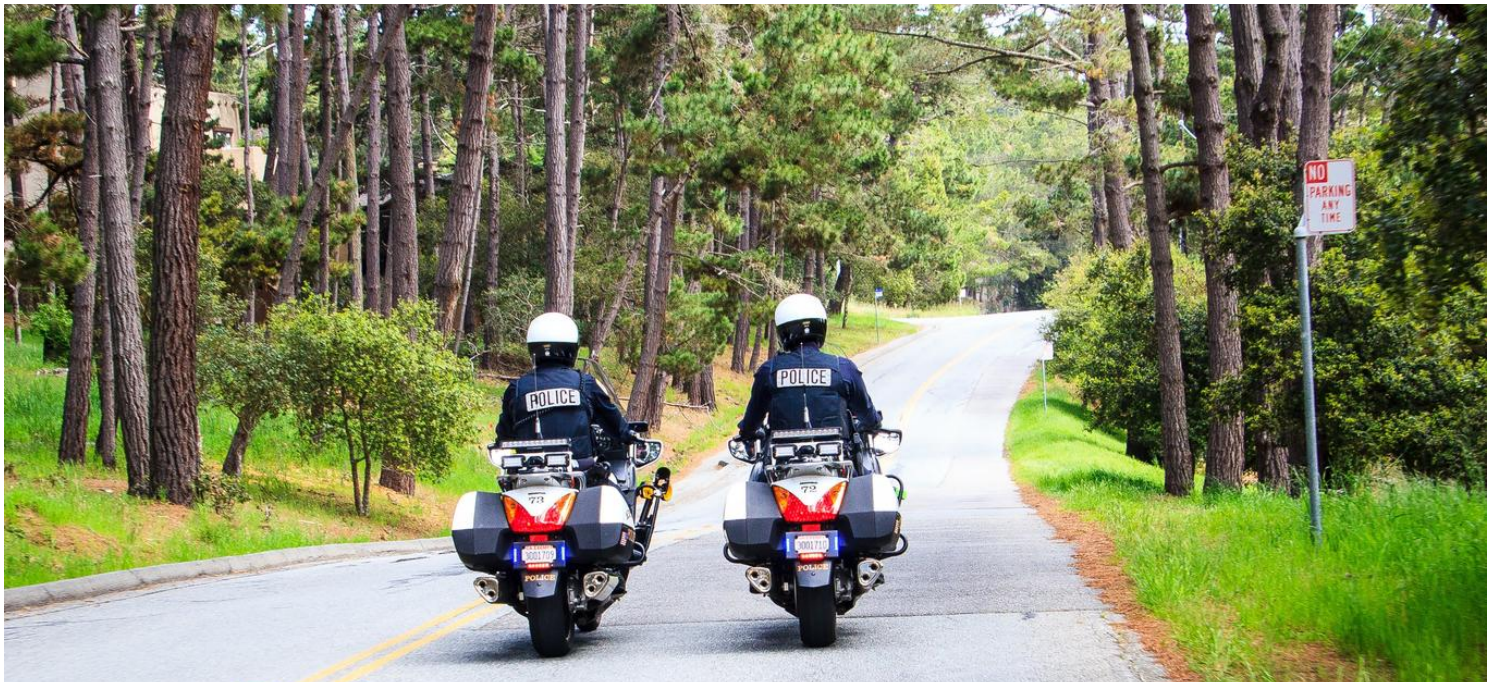

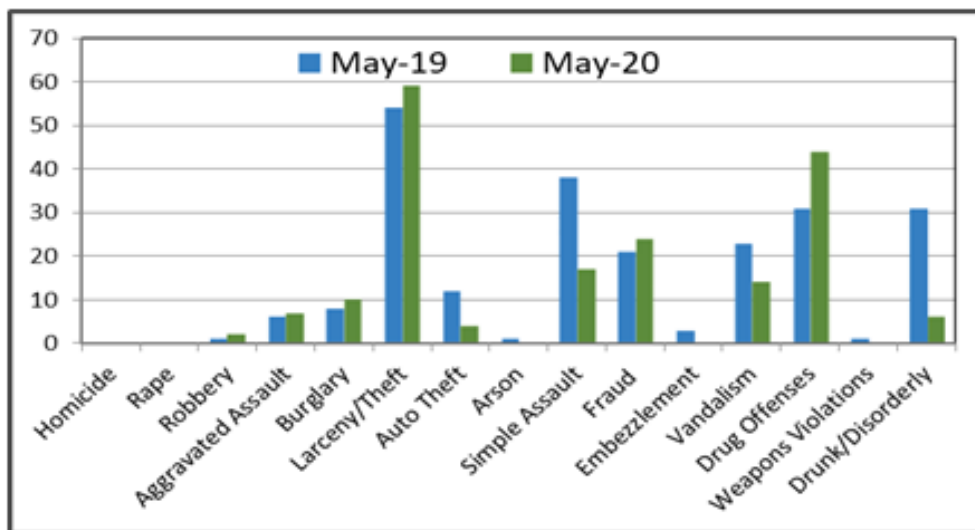


Table A – May 2019 v. May 2020

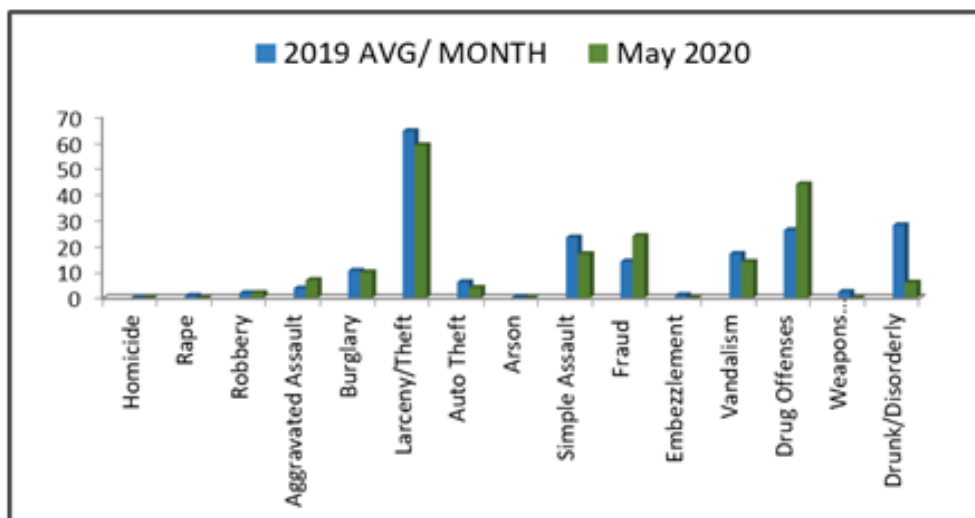


Table B – 2019 Monthly Average v. May 2020
