Citizen Commendation

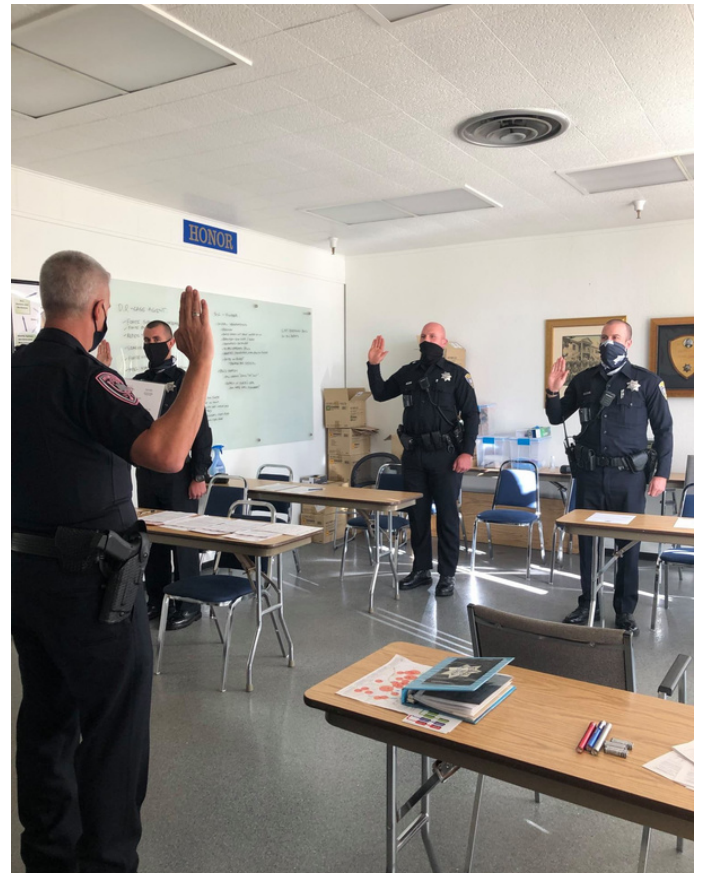
"...it was obvious the officers were trained to deal with people who have mental issues...the officers made a difficult situation much easier because of their kindness and willingness to help someone in need."

In early October, MPD officers were dispatched to a call regarding a subject who had called the suicide hot line and made suicidal statements. The officers were able to build a rapport with the subject and transported him to the hospital for a mental health evaluation.

A few days later, the subject called an MPD supervisor to commend the responding officers for their professionalism and compassion. He related that the officers were patient with him and let him vent, which made him feel at ease. The subject mentioned that it was obvious the officers were trained to deal with people in crisis and with people who have mental health issues. He related that the officers made a difficult situation much easier because of their kindness and willingness to help someone in need. The subject wanted the officers to know that they made a positive difference in his life.

Protests / Rallies

The MPD increased overtime staffing on weekends to assist with ensuring peaceful rallies.

- 10-03-2020 & 10-04-2020 Saturday & Sunday – The MPD monitored political rallies on both days at Window on the Bay, which included counter rallies across the street. MPD interceded several times as members of one group or the other got close to the other group and started arguments.
- 10-10-2020 Saturday – The MPD monitored a political rally at Window on the Bay, which included a counter rally across the street.
- 10-17-2020 Saturday – The MPD assisted with a Women's March through Monterey.
- 10-17-2020 Saturday – The MPD monitored a political rally at Window on the Bay, which included a counter rally across the street.
- 10-24-2020 Saturday - The MPD monitored a political rally at Window on the Bay which included a counter rally across the street. During the assembly, a 9 year old girl alleged someone struck her with a sign while trying to position the sign in front of the child.
- 10-25-2020 Sunday – The MPD monitored a large Trump car caravan parade through Monterey, Pacific Grove and other Peninsula cities.
- 10-31-2020 Saturday - The MPD monitored a large car caravan titled "Riden for Biden," which traveled between Monterey, Seaside, and PG. The MPD also monitored a Trump rally at Window on the Bay and a counter protest across the street. Several times during the event, small groups from each side crossed over Del Monte into the opposing group. Officers on foot directly intervened on several occasions where verbal arguments occurred, or when pedestrians began entering the roadway. Early intervention and warnings were effective in calming the situation.
- 11-01-2020 Sunday – The MPD monitored a large car caravan titled, "The Trump Train," which traveled through Monterey. The MPD also monitored a rally at Window on the Bay and a counter protest across the street. Several vehicles engaged in verbal arguments with the rally attendees. On several occasions persons got out of the vehicles that were in the roadway to challenge the rally attendees. One vehicle collided with a vehicle in front of it while the driver yelled at persons at the rally. At the end of the rally, a passenger in a vehicle threw a beer can onto the sidewalk. The MPD dealt with each of the issues before they resulted in more serious incidents.

COVID-19

Education / Enforcement

The MPD has actively worked with the Monterey City Code Compliance officers, City Attorney's Office and District Attorney's Office to ensure businesses and individuals were complying with the City, State and County COVID-19 guidelines.

- Saturday 10/3/2020 – CSOs directed mask enforcement on Cannery Row and near Wharf 1 - (0) mask violations
- Saturday 10/10/2020 - CSOs directed mask enforcement on Cannery Row, Wharf 1, Alvarado Street and Wharf 2 – (0) mask violations / (5) masks provided
- Sunday 10/11/2020 – CSOs directed mask enforcement on Cannery Row, Wharf 1, Recreation Trail - (0) mask violations
- Saturday 10/17/2020 – CSOs directed mask enforcement on Cannery Row, Wharf 1, Wharf 2, Alvarado Street – (0) mask violations / (4) masks provided
- Sunday 10/25/2020 – CSOs directed mask enforcement on Cannery Row & Wharf 1 - (0) mask violations
- Saturday 10/31/2020 – CSOs directed mask enforcement on Cannery Row, Wharf 1, Wharf 2 & Alvarado Street – (0) mask violations / (4) masks provided
- 10-06-2020 – MPD CAT received a report of a church operating in violation of the SIP. MPD staff contacted the pastor at the Church and explained the SIP order. The pastor agreed to stop holding indoor service.
- 10-13-2020 – MPD CAT received a report about a group using Ferrante Park for softball practice. The coach and team refused to leave the park after officers educated them on the park closure. The coach was issued a citation for violation of having a group activity at a park without a permit (23-12 MCC).
- 10-14-20 – MPD CAT responded to a report of a church operating in violation of the SIP. Upon investigating the situation, the MPD learned that the County Health Department had been in communication with the church. It was determined some employees were allowed to be inside the church in order to facilitate the live stream of services.

Education / Enforcement (Continued)

- 10-15-2020 – After the MPD received complaints about restaurants not being in compliance with directives of the health orders, MPD Detectives visited (7) businesses, in an undercover capacity. Of the seven businesses visited, all but one were in compliance. The following businesses were visited:
 - Lala Palooza, 474 Alvarado (violation observed and incident documented)
 - Britannia Arms, 444 Alvarado
 - Alvarado Brewery, 426 Alvarado
 - Crown and Anchor, 150 W. Franklin
 - Comanche Cellars, 412 Alvarado
 - Cibos, 301 Alvarado
 - Indian Summer, 220 Olivier
- 10-19-2020 - Officers were dispatched to L’Roy’s Smokehouse at 794 Lighthouse for a reported violation of the SIP. A violation was observed, the manager was educated about the violation of the order, and the incident was documented.
- 10-20-2020 – MPD CAT received a report about a group using Ferrante Park for softball practice (the same group from 10/13). The coach and team refused to leave the park after officers educated them regarding the park closure. The coach was issued a second citation for violation of having a group activity at a park without a permit (23-12 MCC).
- 10-22-2020 – MPD CAT received a report of a yoga studio operating in violation of the SIP. Officers visited the yoga studio on 10/21 and 10/22 and found it closed both days.
- 10-27-2020 – MPD CAT received a report about a group using Ferrante Park for softball practice (the same group from 10/13 & 10/20). The coach and team refused to leave the park after Officers educated them on the park closure. A coach (different from the previous coach) was issued a citation for violation of having a group activity at a park without a permit (23-12 MCC). The coach who had previously been cited, continuously yelled at the officers as they cited the other coach.
- 10-30-2020 – MPD officers were conducting foot patrol on Wharf 1 when they contacted three subjects for mask violations.
- 10-31-2020 – The MPD was advised that Silva’s nightclub located at 2110 N. Fremont was advertising a Halloween party. MPD investigated and learned that the nightclub was going to have a “virtual party” livestreamed and would only have people present to assist with the production. MPD consulted with the County Health Department and determined that a livestreaming production event could only occur under very strict circumstances to be in compliance with the health order. Silva’s nightclub decided to cancel the event



Patrol

- 09-29-2020 – MPD officers assisted CHP with a fatal solo motorcycle collision at Highway 1 and Casa Verde. MPD officers arrived on scene first and provided CPR prior to being relieved by medical personnel and CHP.
- 09-30-2020 – MPD officers responded to a call of a subject who had threatened a woman and a child. When officers arrived, the subject was carrying a three- foot construction level and told officers to, “kill me,” as he advanced toward them. The subject would not comply with officer’s requests and officers deployed a taser device to take the subject into custody. The subject was transported to CHOMP for a mental health evaluation. The incident was documented and the case was forwarded to the District Attorney for filing of charges.
- 10-01-2020 – At approximately 4:20 am, American Medical Response (AMR) paramedics requested emergency assistance in the area of Highway 1 southbound, between Soledad and Munras, for a combative patient attempting to pull the paramedic out of the moving ambulance. Monterey PD, Sand City PD and the CHP responded. Officers arrived and found the paramedic who had been assaulted by the suspect. The suspect had pulled the paramedics boot off, stolen his radio, and fled after the ambulance drove away to get away from the suspect. Other officers responding to the call located the suspect running down the freeway with no shirt on and chest leads attached to him. He was taken into custody.
- 10-03-2020 – A female entered an interior courtyard of the MPD/MFD campus known as the “lemon grove.” The woman started talking through an open window to a fire captain who was sleeping and asked for help. When the fire captain went outside to talk to her, she jumped in the window and began wandering around the fire station unaccompanied. The MPD contacted her and took her to CHOMP for a mental health evaluation.
- 10-06-2020 - An MPD employee arriving at work witnessed a suspect attempting to enter another employee’s vehicle in the MPD restricted parking lot area. The incident was captured on surveillance video. The MPD employee advised officers who located the suspect in the area of Pacific and Madison. The suspect was cited and released.
- 10-07-2020 – At approximately 6:30 pm, MPD officers were dispatched to a possible drunk driver at the McDonald’s on Del Monte. MPD responded and the vehicle was not located. At approximately 7:55 pm, the same vehicle was involved in a double shooting in Salinas.
- 10-09-2020 – At approximately 11:30 pm, the MPD responded to a traffic collision that caused a pole to fall down near the tunnel on Del Monte. MPD closed the southbound tunnel for approximately thirty minutes while public works cleared the pole.



Patrol (Continued)

- 10-17-2020 – At approximately 2:13 am, the MPD responded to Pacific Grove to assist PGPD with a subject who was armed and barricaded in an apartment. PGPD was able to negotiate with the suspect and he surrendered.
- 10-23-2020 – At approximately 12:19 am, MPD officers responded to a report of two males with handguns in a stairwell of the West Garage. MPD established a perimeter of the area and located the two subject on Del Monte in front of Chase Bank. Both subjects had what appeared to be guns when officers detained them. The guns were determined to be BB guns.
- 10-23-2020 – At approximately 11:32 pm, MPD officers responded to a report of a subject throwing construction materials into the roadway at Munras and Webster. Officers arrived and attempted to detain the subject and he kicked one officer in the leg. The officers arrested the suspect and booked him at County Jail.
- 10-24-2020 – At approximately 8:15 pm, MPD Officers responded to a report of a subject prowling at a landscape business in the 2600 block of Garden Road. The MPD started to set up a perimeter and requested assistance from Del Rey Oaks PD, as part of the perimeter included airport property. While searching the area, officers observed a male running from the area. The subject was detained and arrested.
- 10-30-2020 - MPD responded to Navy property to assist Naval Support Activity Monterey Police Department (NSAPD) with a loose aggressive dog. MPD was able to capture the dog with an animal control pole. The dog was taken to the SPCA.

OUTREACH TEAM

Community Action Team (CAT)

- Encampment Noticing & Abatements
 - Noticed (135) encampments
 - Abated (131) encampments
 - (65) Del Monte Beach, (41) Window on the Bay, (15) at Don Dahvee Park, (10) other locations throughout Monterey
 - Officers provided flyers to homeless persons with information regarding services available to them.
- CAT arrested a suspect for a felony warrant after contacting him in the 200 block of Washington.
- See the CAT statistical data table on page 10.

Multi-Disciplinary Outreach Team (MDOT)

- CAT and the MDOT social worker from Montage Health spent time at the transit plaza interacting with the homeless, discussing heroin overdose issues and prevention, as well as providing contact information.
- MDOT and CAT members assisted a homeless individual complete his MediCal application so he can receive additional resources.
- CAT contacted a homeless veteran at the transit plaza and forwarded his information to the Veterans Resource Center, so he could potentially obtain services.

- CAT and MDOT coordinated a meeting between a homeless veteran and the VRC at McDonalds on Del Monte.
- CAT transported a homeless individual to his appointment with County Behavioral Health in Marina. After the appointment, the individual advised the CAT sergeant that his backpack was broken. The sergeant took the individual to Big 5 and bought him a new backpack.
- A homeless individual who CAT had provided with contact information, contacted CAT and requested to be taken to alcohol rehabilitation. CAT contacted Sun Street Center and were informed that the individual would be accepted after a COVID-19 test. CAT transported the individual to the hospital for a COVID-19 test and then transported him to the Sun Street Rehabilitation Center for treatment.
- CAT transported a homeless individual to his appointment with County Behavioral Health in Marina.
- CAT and MDOT, through the domestic violence specialist, provided gift cards to a homeless woman.
- The Gathering for Women contacted CAT to assist with a homeless woman who requested psychiatric services. CAT responded to Gathering for Women and coordinated with staff and the homeless woman. CAT transported the woman to CHOMP and coordinated with the MDOT Montage social worker to obtain assistance for the woman.
- CAT coordinated with Interim to provide services for a homeless individual who suffers from PTSD.
- CAT transported a homeless female to CHOMP and coordinated with MDOT, so when the woman was discharged she was provided resources at the Manzanita House.



Investigations

- 10-09-2020 – Texas law enforcement contacted the Presidio of Monterey Police Department (POMPD) requesting assistance in locating a subject who was wanted for homicide and was visiting military housing in Monterey. POMPD contacted MPD for assistance. Several MPD detectives responded from home and set up surveillance. MPD detectives located the suspect and took him into custody.
- 10-09-2020 – MPD detectives conducted an investigation related to a residential burglary. Detectives were able to identify the subject from a video. The investigation led detectives to a hotel in Campbell, where they located the suspect and arrested him for burglary and possession of a controlled substance.
- 10-20-2020 – MPD detectives followed up on a shots fired case, which occurred on 09-22-2020 near the 100 block of Tide in Monterey. The detectives developed information for a search warrant in Greenfield related to the case. The Peninsula Regional Special Response Unit served the warrant due to the potential risk factors associated with firearms and other related issues. After the location was secured the MPD detectives searched and located evidence.

- 10-24-2020 – The MPD developed information that large quantities of methamphetamine were being transported and sold on the Monterey Peninsula. During the investigation, detectives identified a Monterey resident as a person that was involved with the distribution and sales. MPD detectives obtained a search warrant for a location in Cachagua. On 10-24-2020 MPD detectives, with the assistance of the Monterey County Sheriff's Office, and the Drug Enforcement Administration, served a search warrant on Cachagua Road in Carmel Valley. Detectives located four pounds of crystal methamphetamine, heroin, powdered fentanyl, drug paraphernalia, evidence of identity theft, and \$30,000 in cash. MPD arrested and booked the subject into County Jail.



- 10-27-2020 - Detectives developed information about a wanted felon who was in possession of a stolen vehicle. Detectives obtained a warrant and conducted surveillance at a motel on N. Fremont in Monterey. Detectives served the warrant and arrested the suspect for possession of the stolen vehicle and drug violations. Detectives also arrested five other subjects for drug violations. An additional stolen vehicle was also located and recovered.

Narcan Administered Lifesaving

During 2020, the MPD has administered Narcan (16) times to persons who were overdosing on heroin or related opioids.

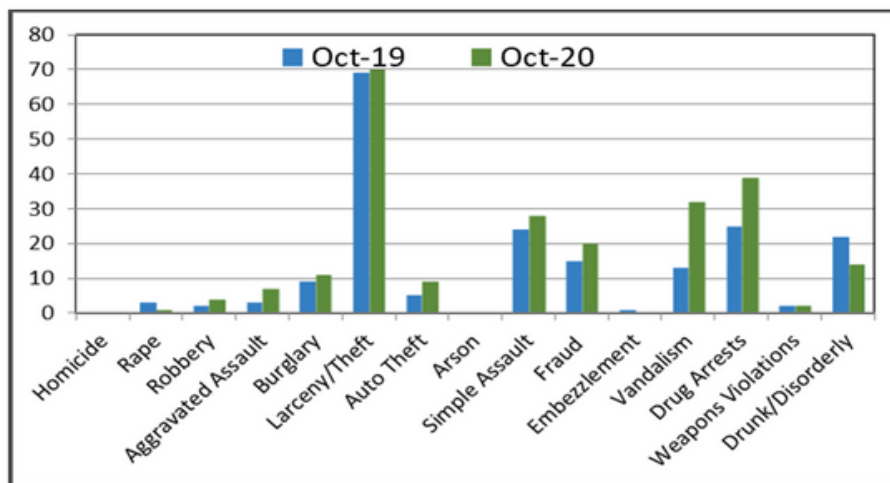


Table A- October 2019 v. October 2020

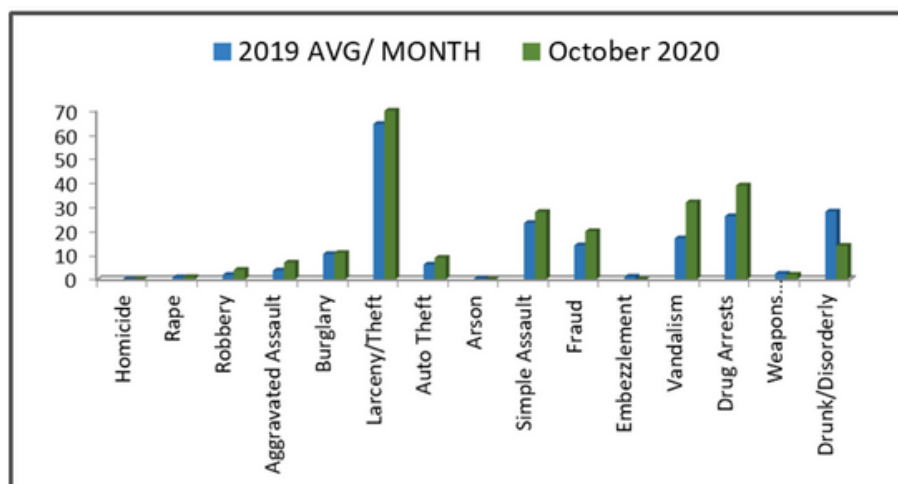


Table B- Monthly Average v. October 2020
