

Citizen Commendations

"...The officer went above-and-beyond expectations and was extremely professional and courteous and made a lasting impression..."

On November 1, 2020, a Monterey Police officer was on a foot patrol and located a credit card protruding from a parking meter. The officer surmised that someone who had parked there had forgotten to retrieve their card after paying for parking. The officer was able to locate several possible phone numbers for the owner and after several calls was able to speak to the owner of the card, who was relieved that the card had not been stolen. The owner of the credit card later called the Monterey Police Department to offer a commendation for the officer. He expressed that the officer went above-and-beyond expectations and was extremely professional and courteous and made a lasting impression on him.

On November 22, 2020, a business owner wrote to the MPD to express his appreciation for a job well done. Officers had responded to his business during a burglary and were able to locate the suspect and take him into custody after he had fled from the scene.





Protests / Rallies

The MPD increased overtime staffing on weekends to assist with ensuring peaceful rallies.

- 11-01-2020 Sunday The MPD monitored a large car caravan titled "The Trump Train," which traveled through Monterey. The MPD monitored a rally at Window on the Bay and a counter protest across the street. Several vehicles engaged in verbal arguments with the rally attendees. On several occasions persons got out of the vehicles that were in the roadway to challenge the rally attendees. One vehicle collided with a vehicle in front of it while the driver yelled at persons at the rally. At the end of the rally, a passenger in a vehicle threw a beer can onto the sidewalk. The MPD dealt with each of the issues before they resulted in more serious incidents.
- 11-07-2020 Saturday The MPD monitored a political rally at Window on the Bay.
- 11-08-2020 Sunday The MPD monitored a political rally at Window at the Bay and in front of the Republican Headquarters on Del Monte. A counter rally occurred in close proximity. Toward the end of the rally a passer-by threw a beer can at the group. The MPD assisted to ensure issues were addressed before they became more serious.

- 11-15-2020 Sunday The MPD monitored a political rally of approximately 150 people at Window on the Bay, which included a counter rally in close proximity.
- 11-22-2020 Sunday The MPD monitored a political rally of approximately 100 people at Window on the Bay, which included a counter rally in close proximity.
- 11-29-2020 Sunday The MPD monitored a political rally of approximately 100 people at Window on the Bay, which included a counter rally in close proximity.



COVID-19 Education / Enforcement

The MPD has actively worked with the Monterey City Code Compliance officers, City Attorney's Office and District Attorney's Office to ensure businesses and individuals were complying with the City, State and County COVID-19 guidelines.

Directed Mask Enforcement

- 11/8/20- MPD CAT received a report regarding a restaurant allowing indoor dining. Officers contacted the restaurant owner, educated him about the SIP orders and the owner ensured compliance with the order.
- 11/27/2020- MPD Officers responded to a report of a party and located five juveniles inside the residence, in violation of the SIP order. The juvenile's parents were contacted and responded to the party and took custody of the juveniles.
- 11/29/2020 CAT responded to a group of 20 people utilizing the volleyball court at Window on the Bay. MPD ensured the group left and did not return.





From 03-18-2020 to date, the MPD has issued the following citations related to COVID-19 violations:

- (8) Shelter in Place violation citations.
- (6) Closed Beach violation citations.
- (3) Group Activity in Parks without permit (sporting events) violation citations.

<u>32 HOURS</u>

The MPD conducted 32 hours conducting face covering education and enforcement every weekend, primarily on Cannery Row, Wharf 1, Wharf 2, on the Recreation Trail and on Alvarado Street.



Patrol

- 11-03-2020 The MPD and Monterey Fire Department responded to a call of a fire (a piece of plywood leaned against a bridge) in the 90 block of Pacific. Monterey Bay Aquarium security observed a male leaving the area of the fire and provided officers with a description. Officers located a subject matching the description and after an investigation determined he was responsible for the fire, arrested him and booked him at the Monterey County Jail for arson.
- 11-02-2020 A man drove his vehicle into his girlfriend's vehicle during a road rage incident. The MPD conducted an investigation and located the subject the following day. MPD arrested the subject and booked him at the Monterey County Jail for assault with a deadly weapon, domestic violence, and violation of a domestic violence protective order.

- 11-18-2020 Wednesday The MPD investigated a report of a carjacking, which occurred in several homeless involved Monterey and individuals who were all known to each other. While stopped at an intersection, one male attempted to carjack another male and the victim of the carjacking attacked the suspect with a The suspect was transported to machete. CHOMP and once medically cleared, was arrested and booked at Monterey County Jail for carjacking. Further investigation resulted in the arrest of a female suspect for conspiracy in assisting in setting up the carjacking. The victim of the carjacking was also later arrested for assault with a deadly weapon against the suspect of the carjacking.
- 11-22-2020 Sunday MPD officers investigated information related to a parolee at large with a gun in a motel room in Monterey. Officers located the subject, arrested him and conducted a search of his room. Officers located a firearm, illicit drugs and drug paraphernalia.
- 11-25-2020 MPD assisted the Kiwanis Club and the Monterey County Food Bank deliver twentyeight Thanksgiving meals to families.
- 11-28-2020 Saturday MPD officers were dispatched to a burglary in progress. Prior to officers arriving, the suspect left and the reporting party followed the suspect vehicle. Officers located the suspect vehicle and stopped it. Officers arrested the suspect for burglary, possession of burglary tools, stolen property, a probation violation and a burglary warrant and booked him into Monterey County Jail



Community Action Team (CAT)

- Encampment Noticing & Abatements
 - Noticed (72) encampments
 - Abated (62) encampments
 - (21) Del Monte Beach, (1) 900 Sloat, (3) Roberts Lake, (9) Don Dahvee Park, (8) Irish Canyon, (13) Dog Park, (1) La Playa Condominiums, (6) Window on the Bay.
 - Officers provided flyers to homeless persons with information regarding services available to them.
- CAT arrested a suspect for a felony warrant, felon in possession of a firearm and ammunition.
- CAT arrested a suspect for possession of 51 grams of methamphetamine, 21 grams of heroin, 75 alprazolam tablets and a probation violation.
- CAT arrested a subject leaving Chatswood Place with a large amount of marijuana, methamphetamine and warrants.
- CAT assisted with the delivery of Thanksgiving meals.

Multi Disciplinary Outreach Team (M.D.O.T.)

- CAT/MDOT collaborated to assist a subject with temporary housing (motel). He agreed to partner with Interim and was also assisted with transportation to a job interview and a ride from the veterinarian.
- CAT/MDOT (VRC) collaborated to house a homeless veteran. CAT also assisted the veteran utilizing a computer and filling out paperwork in order for him to start getting his pension again.
- CAT transported a domestic violence victim to a shelter in Salinas.
- CAT assisted a homeless individual into rehabilitation at Sun Street and transported him there.
- CAT transported a homeless male to MOCO Behavioral Health in Marina for an evaluation.
 He was processed and has two appointments scheduled for December.
- A homeless individual met with the Interim social worker and was transported to a motel and referred to an optometrist for an eye appointment.





Investigations

- Detectives conducted surveillance on a cold case homicide suspect in Sacramento and later returned with a warrant for DNA. The investigation is ongoing.
- Detectives coordinated with the FBI in a canine search of a wooded area in Fort Ord related to a cold case missing person.
- The investigations staff assisted with the instruction of Integrating Communications, Assessment and Tactics (ICAT) training to MPD officers.
- Detectives assisted the DA's office with an investigation into EDD fraud involving county jail inmates.
- Detectives authored and served a Gun Violence Restraining Order (GVRO) and took custody of a handgun.


Narcan Administered Lifesaving

 11-10-2020 - MPD administered Narcan twice on a subject who overdosed at a homeless camp. The male was transported to CHOMP and is expected to survive.

Trainings

- 11-16-2020 and 11-24-2020- ICAT Training—
 Fourteen MPD staff members attended the 16-hour training (8 hours per day). Integrating
 Communications, Assessment, and Tactics
 (ICAT) de-escalation training provides methods
 in responding to volatile situations in which
 subjects are behaving erratically and often
 dangerously but do not possess a firearm. The
 16-hour training provided classroom training and
 opportunities to practice the techniques through
 video case studies and scenario based training
 exercises.
- 11-07-2020 and 11-08-2020 SRU Vehicle
 Hostage Training- Funded through local grants,
 this free training was for local tactical teams to
 train on resolving hostage situations involving
 vehicles.





Part I and Part II Crime - November 2020 (as reported to the FBI and pending FBI verification)




Table A- November 2019 v. November 2020




Table B- Monthly Average v. November 2020
