2020 was a challenging year for many families in our community. With the help of local schools and partners in the Multi-Disciplinary Outreach Team, the MPD identified twelve Monterey families in need this holiday season. All of the MPD employees and the Rotary Club of Monterey donated funds to provide gifts and grocery gift cards for the identified families. On December 16, 2020, a caravan of decorated Monterey Police vehicles chauffeured Santa and with his help delivered gifts and traveled throughout the City of Monterey with hopes of brightening spirits along the way.

MPD Commendation

On December 16, 2020, MPD units were dispatched to a disturbance involving firearms. Officers located four individuals: one suspect with an assault rifle-style pistol and one with what turned out to be an imitation firearm. As officers detained the four suspects, two of them fled on foot. Officers and detectives began searching for the two outstanding suspects. Officers determined that the suspects fled to a nearby apartment where MPD took the two outstanding suspects into custody. The MPD staff worked together to make four arrests and remove a dangerous firearm from the community.

Protests / Rallies

The MPD increased overtime staffing on weekends to assist with ensuring peaceful rallies.

COVID-19 Education / Enforcement

The MPD has actively worked with the Monterey City Code Compliance officers, City Attorney's Office and District Attorney's Office to ensure businesses and individuals were complying with the City, State and County COVID-19 guidelines.

Directed Mask Enforcement

- 12-04-2020 MPD assisted the Monterey County Health Department issue a citation to a local business for operating without a permit after they were issued a closure suspension notice.
- 12-05-2020 MPD assisted the Monterey County Health Department issue a second citation to a local business for operating without a permit after they were issued a closure suspension notice.
- 12-15-2020 Laguna Grande Park MPD responded to a report of subjects playing soccer on the field. MPD arrived and located approximately six subjects waiting to play. MPD advised them they could not play as the field was closed.
- 12-16-2020 Laguna Grande Park MPD CAT responded to a group of six people playing soccer. The group left the park after MPD admonished them the field was closed.
- 12-16-2020 MPD CAT responded to a report of a dance studio holding in-person classes, violating Shelter-In-Place orders. CAT coordinated with the DA's office and spoke with the dance studio manager. The manager complied and ceased dance classes.
- 12-19-2020 Laguna Grande Park MPD contacted a group playing soccer and volleyball and they left.
- 12-20-2020 Laguna Grande Park two groups contacted at different times during the day and advised the park fields were closed and they left.
- 12-22-2020 Laguna Grande Park MPD dispersed approximately 20 people engaged in various activities at Laguna Grande Park
- 12-27-2020 Laguna Grande Park MPD CAT contacted a group playing soccer and they left the park.
- 12-29-2020 MPD officers detained six males for vandalism at Via Paraiso Park and cited them for various issues including Shelter in Place violations.



From 03-18-2020 to date, the MPD has issued the following citations related to COVID-19 violations:

- (14) Shelter in Place violation citations.
- (6) Closed Beach violation citations.
- (3) Group Activity in Parks without permit (sporting events) violation citations.
- (2) Business operating without a permit after revocation related to health code violations

<u>34 HOURS</u>

The MPD conducted 34 hours conducting face-covering education and enforcement every weekend, primarily on Cannery Row, Wharf 1, Wharf 2, on the Recreation Trail, and on Alvarado Street.





Patrol

- 12-01-2020 The MPD responded to a male at the
 Transit Plaza who was swinging a golf club at a woman. When MPD initially contacted the individual he walked away from them and did not comply with their orders to stop. The subject was taken into custody a block away. The investigation revealed that the subject took the golf club from a woman, threw her to the ground, and choked her.
- 12-06-2020 MPD officers responded to a subject in crisis. Officers subsequently discovered multiple firearms in the subject's residence, including an illegal assault rifle. The subject received a mental health evaluation and was later booked at Monterey
 County Jail for possession of an assault rifle.
- 12-12-2020 MPD responded to a missing "at-risk" adult suffering from several mental illnesses and medical conditions. MPD located the woman in an
 adjacent neighborhood and transported her to the hospital for care.
- 12-14-2020 The MPD issued a Road Block
 Observation Plan of Enforcement (ROPE) after a vehicle was stolen; the vehicle was recovered.
- 12-24-2020 The MPD was dispatched to a subject brandishing a knife. On arrival, MPD recognized the subject and knew that he suffered from mental health issues. MPD officers were able to talk to the subject and he was transported to the hospital for a mental health evaluation.
- 12-25-2020 During the early morning hours there were reports of reindeer pulling a sleigh carrying a large man with a red suit, flying through the sky.

Investigations

- 12-01-2020- A suspect involved in an attempted homicide and carjacking in Monterey that occurred in 2018, was arrested at the United States / Mexico border. The arrest warrant was the result of DNA evidence MPD detectives obtained during the investigation in 2018. In the incident in 2018, the suspect carjacked a Monterey resident near Laguna Grande Park. During the carjacking, an offduty police officer started to intervene, when the suspect fired a gun at the off-duty officer. DNA was collected from the stolen vehicle leading to the suspect's eventual identification and arrest.
- 12-03-2020 MPD Detectives located and arrested a subject who had a felony warrant for intimidating a witness. The arrest led to additional charges of possession of marijuana for sale.
- 12-16-2020 MPD Detectives assisted the District Attorney's Office in locating and arresting a subject who had a warrant for his arrest.
- 12-22-2020 MPD Detectives identified a prolific car thief as a suspect in a recent rash of stolen vehicles in the city. MPD Detectives coordinated with the county Multi-Agency Detail for Commercial Auto Theft (MADCAT) Task Force and located and arrested the suspect in Seaside. The arrest led to MPD Detectives locating property implicating him in multiple other property crimes.

- CAT transported a subject to Sun Street rehabilitation center in Salinas.
- CAT transported a local homeless individual to CHOMP for a psychiatric service. Afterwards, CAT referred the subject to Monterey County Behavioral Health Services to schedule two follow-up appointments.
- CAT assisted a subject enter a rehabilitation program for alcohol abuse at the Genesis House.
- CAT / MDOT transported a subject to CHOMP for psychiatric services and was able to obtain housing for them at the Manzanita House.

Part I and Part II Crime - December 2020 (as reported to the FBI and pending FBI verification)


