

Citizen Commendation

On April 06, 2021: A male subject called to express his gratitude to an MPD Officer and Community Service Officer (CSO). He related that the officer and CSO were instrumental in getting him off the street and sober. According to the subject, he had been living at Window on the Bay for over a year and was addicted to alcohol and methamphetamine. He stated both the officer and CSO approached him several times about services to assist him with his situation and he decided to take them up on their offer. He related that the officer put him in contact with the Genesis House and assisted with the intake process. He related further that he successfully completed the substance abuse treatment program and was currently residing in transitional housing. Additionally, he has found gainful employment as a plumber and will begin his new job in a few days. He felt both the officer and CSO had saved his life. Both the officer and CSO are commended for their persistence and diligence in providing exceptional services to those in need.





COVID-19 Education / Enforcement

The MPD has actively worked with the Monterey City Code Compliance Officers, City Attorney's Office and District Attorney's Office to ensure businesses and individuals were complying with the City, State and County COVID-19 guidelines.

- 04-03-21- A Monterey nightclub had approx. 80 patrons inside the establishment, a live band, dancing, and the majority of patrons not wearing masks, in violation of the SIP order. The owners of the nightclub could not provide copies of the business license or ABC license. Officers provided a paper copy of the COVID-19 guidance for restaurants. The information was forwarded to the District Attorney and ABC.
- 04-11-21- Officers assisted the District Attorney's office with a court order at a Monterey coffee shop.
 Officers stood by while the business's locks were changed and officers confiscated the generator.
- 04-15-21-MPD responded to a complaint regarding employees not wearing masks inside a Monterey business. Officers educated the employees and manager of the business regarding mask requirements.

From 03-18-2020 to date, the MPD has issued the following citations related to COVID-19 violations:

- (15) Shelter in Place violation citations.
- (6) Closed Beach violation citations.
- (3) Group Activity in Parks without permit (sporting events) violation citations.
- (2) Business operating without a permit after revocation related to health code violations.

33.75 HOURS

The MPD conducted 33.75 hours conducting face-covering education and enforcement every weekend, primarily on Cannery Row, Wharf 1, Wharf 2, on the Recreation Trail, and on Alvarado Street.





Patrol

- 04-09-21- MPD officers arrested an individual for throwing rocks at passing vehicles at Fremont and Abrego.
- 04-10-21- MPD units responded to a burglary alarm at a Monterey residence. At the residence, officers located an unsecured garage door. The burglar cut several holes in the garage walls to enter the living space, and took a laptop and miscellaneous jewelry. Officers documented the burglary and the incident is under investigation.
- 04-11-21- Officers responded to a report of a male chasing another male with a knife at the Transit Plaza.
 The male suspect stated the other male was attempting to extort him and began chasing him.
 Officers arrested the suspect for assault with a deadly weapon.
- 04-16-21-Officers arrested two subjects for shoplifting over \$1,000 in merchandise from a Monterey pharmacy. During the search of the subjects' vehicle, Officers located drugs and additional merchandise.
 Officers towed the vehicle, arrested the subjects and transported them to Monterey County Jail.
- 04-29-21- A victim called the MPD to report an assault with a deadly weapon. The victim related he found a subject in his vehicle parked outside of his residence. The victim approached the subject and a struggle ensued. The subject then stabbed the victim in the head resulting in a 2" laceration. The victim drove himself to CHOMP for medical treatment, returned home and called the police. The MPD is investigating the incident.

Community Action Team (CAT)

 - Officers provided flyers to homeless persons with information regarding services available to them.



Multi Disciplinary Outreach Team (M.D.O.T.)

- CAT attended an Adult Services Multi-Disciplinary meeting.
- CAT hosted and participated in the Homeless Monthly Exchange meeting.
- CAT assisted a 22-year-old male with enrollment and transportation to Sun Street Centers.
- CAT assisted a male homeless person with an assessment, enrollment and transportation to treatment at the Genesis House.
- CAT assisted a female homeless person with transportation to the warming shelter in Salinas.
- CAT/MDOT met with a 16-year-old male and his mother to attempt an intervention to encourage the juvenile to enroll in a substance abuse program after the juvenile overdosed twice in the past year.
- CAT/ MDOT and the Veteran's Transition Center helped provide clothing to an individual.
- MDOT provided a homeless person with transportation to the DMV to obtain an ID card.

Narcan Administered Lifesaving

 Monterey PD responded to a report of an 18year-old male who overdosed in his bedroom.
 The Monterey Fire Department administered Narcan and the subject regained consciousness.





Investigations

- 04-01-21- Detectives authored and served a search warrant on an individual in Marina after learning that marijuana was being sold illegally on the Monterey Peninsula for the benefit of a gang member in jail. As a result, detectives located and seized 19.5 pounds of marijuana.
- 04-02-21- Detectives were conducting pro-active enforcement and located a subject violating numerous vehicle codes. Officers located the subject on the street approximately a block from his vehicle and arrested the subject for being under the influence of drugs and possession of drug paraphernalia.
- 04-02-21- Detectives conducting proactive enforcement observed a vehicle committing traffic violations. A police officer stopped the vehicle, and subsequently arrested the driver and passenger for possession of a controlled substance.
- 04-05-21- Detectives investigated a report of a child sexual assault case where the suspect had fled the state. Detectives established enough evidence to obtain an arrest warrant for the suspect. The suspect was arrested in Arizona on a \$1.7 million dollar warrant.
- 04-07-21- Detectives conducting proactive enforcement located and arrested a subject for possession of a controlled substance for sale.
- 04-07-21- Detectives located and arrested a subject on parole who was wanted by the Marina Police Department for domestic violence and assault with a deadly weapon.

- 04-07-21- Detectives contacted a subject known to them to be on searchable probation. Detectives located heroin and arrested the subject.
- 04-09-21- Detectives located a felony no-bail warrant subject in the City of Morgan Hill. The subject was wanted for gun possession charges and possession of a controlled substance for sale. Detectives received information that the subject was selling large amounts of methamphetamine on the Monterey Peninsula. Detectives arrested the subject and located methamphetamine and marijuana for sale. Detectives also arrested the subject's girlfriend for a \$0 bail felony warrant and possession of a controlled substance.
- 04-16-21- Detectives contacted and arrested a subject on probation who had a warrant for possession of a controlled substance, drug paraphernalia and stolen property.
- 04-19-21- Detectives assisted Seaside Police Department detectives with a cold case homicide investigation.
- 04-30-21- Detectives conducted a probation search in the City of Monterey. One male fled on foot and officers arrested him a short distance away. Officers arrested the occupants of the residence for possession of a controlled substance and possession of drug paraphernalia. The owner of the residence was charged with maintaining a drug house.



Part I and Part II Crime - April 2021 (as reported to the FBI and pending FBI verification)




Table A- April 2020 v. April 2021




Table B- Monthly Average v. April 2021
