MPD Commendation

On May 16, 2021: MPD units responded to a report of an armed robbery in progress at a hair salon in Monterey. Officers immediately set up a perimeter around the building. The suspect was inside the business and indicated he was armed and threatened to kill everyone there, including the officers. The officers developed a plan, evacuated the employees from the business and began negotiating with the suspect. While an officer negotiated with the suspect, a team of officers noticed the suspect backing up towards the front door. Officers then approached the suspect from the rear, an officer deployed his Taser, and the officers were able to take the suspect into custody safely.

The suspect's relatives later called to express their gratitude to the officers. The relatives related that the suspect suffered from mental health issues and they were happy officers took their relative into custody safely. The suspect's brother expressed, "I read the press release. I don't know everything my brother did, but he could have been shot that day. Thank you!"





Patrol

- 05-01-2021- MPD responded to a couple attempting to sell laptops and catalytic converters out of their vehicle to passersby's. The couple discarded two laptops and fled the area when officers arrived on scene. Officers retrieved the laptops. The same suspects and vehicle were involved in a burglary that occurred in the City of Seaside. The investigation continues.
- 05-05-2021- MPD officers assisted the Pacific Grove Police Department locate a suspect involved in a vehicle burglary.
- 05-05-2021- MPD officers responded to a burglary in progress where a subject broke a window and entered a building. Officers treated the subject for lacerations on scene, and then arrested and booked the subject at Monterey County Jail for burglary and vandalism.
- 05-06-2021- MPD units responded to a solo vehicle collision and located two injured subjects. AMR transported the subjects to Natividad Medical Center. Salinas Police Department assisted with obtaining statements and a blood draw from the driver after the driver admitted methamphetamine use.
- 05-07-2021- MPD located a stolen vehicle occupied by a wanted parolee.
- 05-07-2021- Monterey PD, Monterey FD, and AMR responded to the Gathering for Women where a homeless female assaulted an employee. Officers arrested and booked the subject at Monterey County Jail.

- 05-09-2021- MPD responded to a driver under the influence who struck a vehicle occupied by an elderly couple. The driver then lost control of the vehicle and crashed into a pole. AMR transported the elderly couple to CHOMP for treatment of non-life threatening injuries. Officers detained and arrested the driver.
- 05-09-2021- MPD responded to a driver under the influence who struck a vehicle causing the suspect vehicle to flip over and skid approximately 200 ft. Del Monte Ave. was closed in both directions of traffic for approximately 40 minutes. Officers arrested the driver.
- 05-11-2021- MPD detectives observed a male and female removing property from a vehicle with a stolen plate affixed to it. Detectives remained in the area and observed the male subject and the vehicle leaving a nearby motel. Detectives attempted contact with the suspect, and the suspect fled. Detectives caught and arrested the suspect a short distance away. While transporting the subject to jail, the subject was able to position his handcuffed-hands in front of him and escape the patrol car. The officer pursued the subject and attempted to tackle the subject. The subject then ran to the police car, stole the police car, and drove towards Veteran's park. In an abundance of caution, the MPD requested Monterey High School and Colton Middle School shelter in place. California Highway Patrol, Monterey County Sherriff's Office, Pacific Grove PD and the Presidio of Monterey PD assisted the Monterey PD with setting up a large perimeter around the area where officers last saw the subject. A citizen reported a man on a rooftop of a house. Officers responded and located the subject on the rooftop. Officers arrested the subject and transported him to Monterey County Jail for the following: resisting arrest, accessory, identity theft, escaping from custody after arrest, possession of a stolen vehicle, and possession of methamphetamine and drug paraphernalia.
- 05-12-2021- An MPD officer located an occupied stolen U-Haul. Officers initiated a high-risk stop and the driver refused to exit. Pacific Grove PD and California Highway Patrol assisted with traffic control and closing of the roadway. Officers obtained a phone number for the suspect and negotiated with him for 30 minutes before he surrendered and taken into custody.
- 05-13-2021- Officers responded to a fatal single-vehicle collision into a utility pole.
- 05-15-2021- A fishing vessel crashed into the jetty and fled back out to sea. The US Coast Guard responded, escorted the vessel to anchorage and detained the boat operator. The MPD took over the arrest once the Coast Guard brought the suspect onshore.



Patrol continued

- 05-21-2021- MPD coordinated with Seaside and Pacific Grove Police Departments to locate a seven-years-old child who was separated from his parents on the recreation trail. MPD located the child at his home in Pacific Grove.
- 05-22-2021- A male reported being threatened by another male brandishing a machete. Officers located and arrested the subject.
- 05-23-2021- MPD, Monterey FD, State Parks, and Harbor Master personnel searched for a runaway 10 year-old in the area of Wharf 1. Monterey Police located the child on the recreation trail at McCormick.

Multi Disciplinary Outreach Team (M.D.O.T.)


- CAT and MDOT assisted MCSO with checking homeless encampments in Carmel Valley.
- CAT gave a presentation to the staff at the Veteran Transition Center on how to identify illicit narcotics.
- CAT coordinated with Gathering for Women to assist a homeless couple and their infant child with a hotel voucher, diapers, food and assistance with registering for benefits.
- CAT provided a homeless person with transportation to CHOMP for medical treatment.
- CAT provided a homeless male with transportation to CHOMP for detox so he can admit himself into the Genesis House for rehabilitation.
- CAT provided a homeless person with transportation to the Salinas Warming Shelter.
- CAT & MDOT assisted a homeless female and her dog with food and with getting on a waiting list for housing.
- CAT & MDOT assisted an individual with transportation to the DMV and assisted in applying for a senior citizen ID card.
- CAT assisted an individual obtain clothing from the Salvation Army.
- CAT assisted an individual obtain clothing and a blanket from the Salvation Army.





Investigations

- 05-05-2021- Detectives attempted to conduct a probation search at a motel. The probationer jumped from the second story balcony of the motel room and fled the area in a vehicle. Patrol officers assisted the detectives and located the vehicle with the probationer inside. Officers stopped the vehicle, conducted a probation search, and located 7 ounces of methamphetamine. Officers arrested all three occupants of the vehicle for various drug charges, including possession of methamphetamine for sale.
- 05-18-2021- Detectives observed a subject on Post Release Community Supervision (PRCS) and attempted to stop him. The individual was a suspect in multiple theft cases. The individual ran from police and detectives pursued the subject. Detectives stopped the subject and arrested him for delaying and obstructing arrest. Detectives also located heroin, methamphetamine and marijuana on the subject.
- 05-25-2021- Detectives observed a suspicious vehicle occupied by three individuals at a motel parking lot. Detectives coordinated with patrol to initiate a traffic stop. During the investigation, detectives learned one subject had a felony arrest warrant and the other two individuals were on probation. During a probation search, detectives located cocaine and methamphetamine for sale, identity theft materials, burglary tools, and drug paraphernalia.
- 05-27-2021- Two detectives and a MPD reserve officer assisted the Monterey County Cold Case Homicide Task Force with two cold case homicides from King City.
- 05-28-2021- Detectives located a stolen unoccupied vehicle and returned the vehicle back to the owner.






Table A- May 2020 v. May 2021




Table B- Monthly Average v. May 2021
