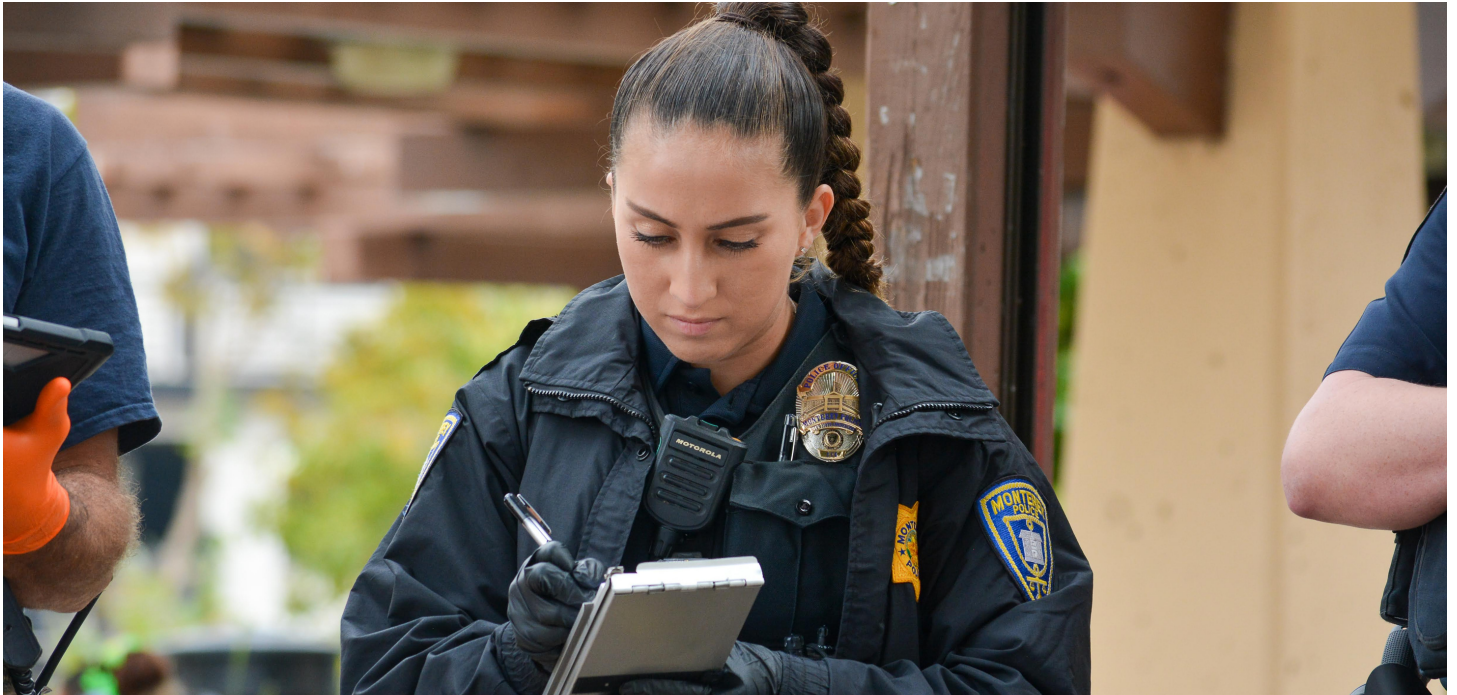


MONTHLY REPORT

Citizen Commendation

I am writing to you to commend your department and specifically the officer who assisted me. I was deeply concerned that my husband had left our home, without announcing his intentions, and had been gone for three hours. My husband suffers from a disorder. He had left before and had been gone over two hours before returning, so I waited three hours or so. This was not like my husband and I was so frightened.

The officer was so kind and professional over the next several hours. After taking his report he followed up with calls and kept me informed of what actions he was putting in place. He came by the house again to be sure we had not missed any clues. I was reassured with the effort, procedures and resources your department has in place to help locate vulnerable persons. Knowing that the officer and the team were doing everything that could possibly be done to locate my husband, was so reassuring and although I continued to be concerned, I was so thankful for the officer and the care and attention he put into directing the search for my husband.

As you know, there was a very happy ending...my husband found his way home. Please let the officer know that he made all the difference for me that day and I will never forget his kindness and professionalism. Patrol

- 08-01-21- MPD officers responded to a rollover collision and arrested the driver for driving under the influence of alcohol.
- 08-01-21- MPD officers responded to a pedestrian who was struck by a vehicle while crossing the street. The pedestrian sustained injuries to the pelvis and left arm. AMR transported the pedestrian to Natividad Medical Center.
- 08-01-21- MPD officers responded to a past-tense report of a residential burglary. Officers learned the burglar forced entry into the victim's residence and left once confronted by the resident. The resident chased the fleeing suspect and captured images of the suspect and the suspect's vehicle on a cell phone. Officers identified, contacted, and interviewed the suspect. The report was forwarded to the District Attorney for prosecution.
- 08-05-21- MPD responded to a reported theft at Del Monte Shopping Center. Officers located the 20-years-old male and the 17-years-old female suspect. Officers arrested and booked the male suspect for contributing to the delinquency of a minor, conspiracy to commit a crime, possession of a controlled substance, probation violation, and possession of drug paraphernalia. The juvenile was arrested for shoplifting, conspiracy to commit a crime, and possession for a controlled substance.
- 08-06-21- MPD officers assisted Watsonville PD search for an assault with a deadly weapon suspect who was possibly in Monterey. Officers performed multiple checks for the suspect throughout the city, but were unable to locate the suspect.
- 08-14-21- Officers observed a naked man running in the streets of Monterey, acting erratically and believed he was under the influence of drugs or suffering from a mental health crisis. Officers detained the subject safely and transported him to CHOMP for an evaluation.
- 08-15-21- Officers responded to a report of a collision, in which a male subject drove his car into a vehicle occupied by his girlfriend, and subsequently struck two parked vehicles. The subject fled the scene and officers arrested the subject at his residence.



- 08-17-21- MPD officers responded to a domestic disturbance, during which a subject threatened to assault the officers. Officers arrested the subject. While the subject was placed in the patrol vehicle, he began kicking the windows and the door. The subject also began banging his head against the vehicle window. Officers repositioned the subject and placed him in a restraint device so he would not injure himself. The suspect was transported to Monterey County Jail.
- 08-20-21- The MPD responded to a report of a physical domestic dispute. The subject had been arrested by officers two days prior for domestic battery and was out on bail. Officers arrested the subject for domestic battery.
- 08-21-21- MPD officers arrested a homeless male for assaulting a homeless female with a liquor bottle and stealing her backpack.
- 08-21-21- Officers responded to a physical altercation between two subjects. The victim was stabbed in the face with a fork. During the investigation, officers obtained video footage and evidence, and later located and arrested the subject for assault with a deadly weapon.
- 08-26-21- The MPD assisted State Parks with a vehicle check. During the investigation, officers located a firearm and ammunition in the subject's car and arrested him.
- 08-30-21- MPD investigated a report of firearms displayed from a vehicle. Officers located the vehicle and the driver was found to be in possession of two imitation firearms (BB guns).



Community Action Team (CAT)

- Encampment Abatement
 - Abated (48) encampments
 - (7) Iris Canyon / Via Mirada; (28) Window on the Bay; (1) 200 Ramona; (2) 3rd and Aguajito; (2) Behind the Library in the Creek; (2) Recreation Trail (Del Monte & English); (1) Wharf 2 Bathroom; (1) 200 Glenwood Circle; (2) Don Dahvee; (1) Quarry Park; (1) Visitor Center.
 - Officers provided flyers to homeless persons with information regarding services available to them.
- CAT participated in a meeting with MCPOA and provided information related to how MPD MDOT and CAT provide services for unsheltered subjects.
- CAT collaborated with Cal-Trans and their Homeless Task Managers to assist with camp abatement along Cal-Trans property.
- CAT transported a homeless subject to the Sun Street Center to start a substance abuse program.
- CAT assisted a subject with transportation to the social services office to obtain an ID card voucher, and then transported the subject to the DMV.
- MDOT transported a homeless female to the Gathering for Women where she obtained food and clothing.
- CAT officers performed a welfare check on an elderly homeless couple living out of a vehicle. Officers escorted the couple to Gathering for Women, where the female obtained food, clothing and toiletries. The couple applied for senior housing, however, the couple then declined available housing.

Multi Disciplinary Outreach Team (M.D.O.T.)

- MDOT/ CAT assisted with finding permanent housing for an elderly woman at the House of Peace.
- MDOT/ CAT placed a subject on a psychiatric hold after he was found gravely disabled and living in a box trailer. The subject was housed in a residential skilled nursing facility.
- CAT drove a homeless subject to his dental appointment in Salinas. MDOT (Interim) assisted with a hotel for his recovery.

Narcan Administered Lifesaving

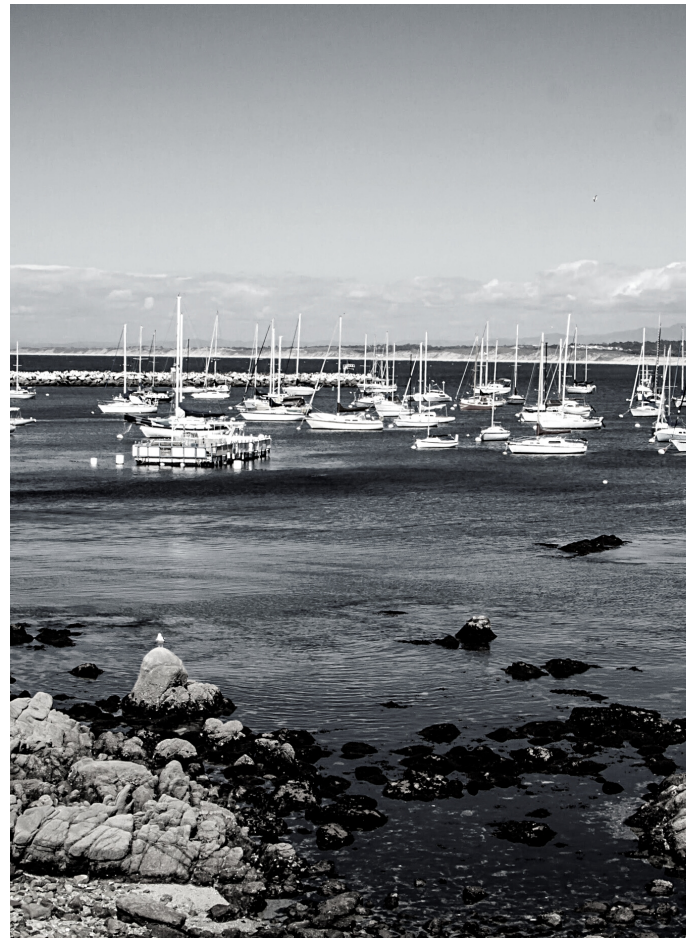
- 08-21-21- Officers responded to a motel regarding a report of a fentanyl overdose. The subject was administered two doses of Narcan and AMR transported the subject to CHOMP.
- 08-22-21 Officers located a subject down on the side of the road and administered one dose of Narcan. The subject regained consciousness and was transported to CHOMP.

Case Study - John Doe 821 (August 2021)

In an effort to explain some of the challenges faced by the MPD in trying to problem solve through a variety of ways, this case study highlights aspects that the MPD and partners in MDOT face while attempting to resolve issues:

- John Doe 821 is a 32 years-old male who is homeless and suffers from mental illness. From July 2005 to June 2021, the MPD has had 233 documented contacts with Doe 821. Most of the calls related to Doe 821 involve thefts, public intoxication and peace disturbances. Doe 821 generates a high volume of calls in the downtown/ Transit Plaza area. He has a history of resisting arrest and battering officers in the process of taking him into custody. In 2020, Doe 821 was responsible for several theft and prowling cases in several residential neighborhoods throughout Monterey.
- The MPD has arrested Doe 821, (40) times from 2007 to 2021, for issues such as burglary, theft, false identification, domestic violence, brandishing a weapon, disturbing the peace, resisting arrest, challenging others to fight, drunk in public, possession of stolen property and warrants. In many cases, Doe 821 was out of custody within 24-hours of the arrest. In other instances, people call the MPD, but do not want to press charges and for misdemeanor offenses not personally viewed by a police officer, someone must request to have charges filed.
- The MPD has placed Doe 821 on a hold for evaluation by a mental health professional on (4) occasions. To be placed on a hold the subject must be a danger to himself, danger to others, or gravely disabled (requirements for a mental health evaluation 5150 H&S). Mental Health holds are for up to 72 hours, and usually the subject is not held for 72 hours.

In 2019, Doe 821 declined services on five occasions. In 2020, Doe 821 requested services on two occasions. In 2021, Doe 821 has shown more interest in obtaining services and it is hoped he will participate and find success.



Investigations / Monterey Police Anti-Crime Team (IMPACT)

- 08-05-21- MPD detectives conducted a probation search and arrested a subject for violation of probation and possession of controlled substances.
- 08-16-21- Detectives followed up on a reported armed robbery and determined a victim of a previous theft took his own property back. Both cases were closed.
- 08-17-21- Marina PD located a vehicle that contained stolen property and had the vehicle towed to the Monterey Corporation Yard. MPD detectives authored a search warrant and recovered the stolen property related to a theft that occurred at a Monterey hotel earlier this year.
- 08-30-21- Detectives recovered stolen lawn equipment from a burglary that occurred in 2020 and notified the property owner. The investigation is ongoing.
- 08-31-21- Detectives assisted the Monterey County Cold Case Unit with mobile audio and video surveillance.

Table A- August 2020 v. August 2021

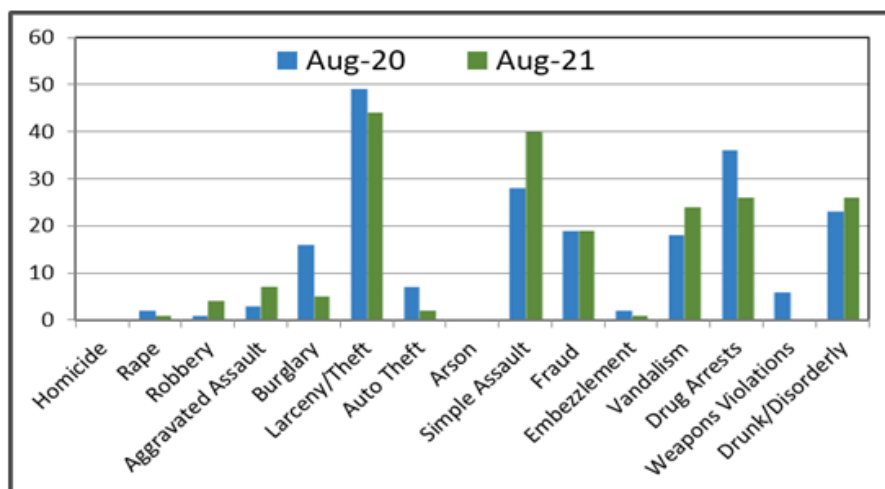


Table B- Monthly Average v. August 2021
