

MPD Commendation

On November 14, 2021, an MPD officer responded to a report of a past-tense domestic violence incident that occurred in Monterey. The officer learned that the victim had been beaten and choked the day prior and was now staying at a hotel due to fear of returning home. While interviewing the victim, the suspect tried to learn the location of the victim through a phone application. Through further investigation, the officer located the suspect's residence in San Jose. The officer began communicating with the San Jose Police Department, who located the suspect's vehicle. The MPD officer completed a warrant for the suspect, which the on-call judge approved on the first request and complimented the officer for its thoroughness and completeness. San Jose PD ultimately arrested the subject the following day pursuant to the warrant. The MPD officer is commended for going above and beyond to ensure the suspect was apprehended.





Patrol

- 11-01-2021- MPD officers arrested a driver who was under the influence after the driver collided with a tow truck, causing minor injuries to the tow truck driver.
- 11-04-2021- Officers responded to a possible domestic violence call. The reporting party stated her boyfriend was naked, on hallucinogenic mushrooms and threatened to kill her as he was getting into his car. The male drove briefly and was involved in a collision with a parked vehicle. Upon officers' arrival, the man ran up to an officer in his patrol vehicle. The male attempted to get into the driver's side. Two other officers took the subject into custody. The male continuously asked for officers' handguns in order to shoot himself. The male was placed on a psychiatric hold.
- 11-05-2021- Monterey PD responded to a report of an intoxicated juvenile who was acting out, and refusing to listen to her parents. The juvenile had probation terms for similar behavior. When MPD attempted to contact the juvenile, the juvenile walked away and down a ravine. Officers convinced the juvenile to walk with them back out of the ravine. The juvenile then tried to walk away from the officers and officers restrained the juvenile and transported her to Juvenile Hall for a probation hold after a medical clearance.
- 11-06-2021- Officers responded to a vehicle that drove off the roadway into a ravine. The driver was uninjured. The street was closed for approximately 1.5 hours while the vehicle was removed from the ravine.

- 11-06-2021- Officers responded to a victim who fell from the second story landing of a building in Monterey. A witness observed the victim climb over the railing prior to the fall. AMR transported the victim to Natividad Medical Clinic.
- 11-07-2021- MPD assisted the Seaside Police Department, which was investigating a shooting. The victim was transported to CHOMP by a family member. MPD units assisted Seaside Police Department at CHOMP by securing the victim's car.
- 11-11-2021- MPD received multiple reports of a male forcing entry into a residence. The suspect threatened the female resident while trying to break down her door with a golf club. Officers responded to the residence and the suspect fled upon officers' arrival. Officers identified and located the suspect. Officers arrested the suspect without incident and transported him to CHOMP for a mental health evaluation.
- 11-13-2021- Monterey police officers responded to a sexual battery. A female walking her dog was grabbed from behind and pulled to the ground. The suspect battered the female and fled the area on foot as a vehicle approached. The female described the suspect to the officers, and the officers located and arrested the suspect a short distance away. Officers arrested the suspect for assault with intent to commit rape, false imprisonment and battery. Officers transported and booked the suspect in the Monterey County Jail. His bail was set at \$110,000.





Patrol Continued

- 11-14-2021- Monterey police officers responded to a 9-1-1 call. The dispatcher could hear a female whispering, "help me." A Monterey officer arrived in the area and found a male suspect sexually assaulting a female in a parked vehicle. Officers removed the suspect from the vehicle. An investigation revealed the suspect approached the female at her vehicle, verbally threatened her, and forced his way into her vehicle where he assaulted her. The suspect was arrested on the following charges: rape by force or fear, false imprisonment, and criminal threats. Officers transported and booked the subject in the Monterey County Jail. A bail enhancement was requested, and bail was set at \$250,000.
- 11-14-2021- MPD responded to a report of a female screaming from her residence. When officers arrived, they could hear the screaming. Officers knocked on the door with no response. Officers forced entry into the residence and located the female victim and male suspect. The victim stated she was struck, held down against her will, and choked while the suspect stated he was going to kill her. Officers arrested the suspect.
- 11-14-2021- MPD assisted the California Highway Patrol respond to a deceased person found on Caltrans Property. CHP took over the investigation.
- 11-15-2021- Pacific Grove Police Department responded to a report of a male stabbed near the American Tin Cannery. Monterey officers assisted PGPD by contacting the Monterey Bay Aquarium Security for video surveillance, conducting area checks, and providing a metal detector for a search of the area.

- 11-16-2021- An MPD officer investigated a case in which a victim's vehicle was vandalized at her place of employment by her former partner. The victim received numerous implied threats. The victim requested an emergency protective order. Officers attempted to locate the suspect at her residence in Seaside but were unsuccessful. The victim returned home and later called to report that the suspect had shown up at her home in Salinas. Salinas Police Department responded to the residence and arrested the suspect.
- 11-18-2021- Officers responded to a residential fire. The elderly residents suffered burn injuries and were transported to the Community Hospital for burn injuries. MPD detectives assisted Monterey Fire Department investigate the fire.
- 11-19-2021-MPD responded to an unresponsive male in a vehicle. MFD and AMR performed CPR and transported the victim to CHOMP where the victim was pronounced deceased.
- 11-20-2021- A Monterey citizen reported that a vehicle was parked in the driveway of his vacant residential property. The citizen provided officers with the license plate information of the vehicle. Officers discovered that the vehicle belonged to an unhoused subject currently out on bail for a federal case. The owner provided keys to the residence and requested that officers clear the residence. Officers arrived at the residence and discovered the locks had been changed and the keys were nonfunctioning. Officers could hear someone inside and asked the subject to come out of the residence. Officers arrested the subject for trespassing, burglary, drug paraphernalia, vandalism and committing a felony while out on bail.



Patrol Continued

- 11-20-2021- Monterey officers found two loaded firearms in a vehicle during a traffic stop in Monterey. Both vehicle occupants were arrested. One suspect was arrested for possession of an unregistered and loaded firearm, possession of a concealed firearm, a felon in possession of a firearm and felon in possession of ammunition. The other suspect was arrested for possession of an unregistered firearm, possession of a loaded firearm, possession of a concealed firearm, and possession of a high-capacity magazine. Both suspects were transported to Monterey County Jail with a bail amount of \$40,000 each.
- 11-24-2021- MPD officers contacted a subject with three no-bail warrants. The subject resisted arrest and bit one officer, and another officer sustained an abrasion to his hand due to the subject's resistance. Officers were able to place the subject in a restraint and arrest him. The subject was not injured. Officers transported the subject to Monterey County Jail.
- 11-26-2021- Monterey officers responded to a strongarmed robbery where four subjects stole \$30,000 in merchandise. The four suspects fled the scene in an unknown vehicle. The investigation is ongoing.
- 11-27-2021- Monterey officers contacted a male subject standing in a roadway. The subject refused to give his identification to the officers for the citation. Officers subsequently arrested the subject. Officers determined that the subject had 3 no-bail warrants and transported the subject to jail.

Community Action Team (CAT)

- Encampment Noticing & Abatement
 - Abated (57) encampments

 - Officers provided flyers to homeless persons with information regarding services available to them.
- CAT gave a presentation to San Carlos School.
- CAT/ MDOT participated in a meeting with CHOMP to discuss an Opiod Response Team.
- CAT continued to work with Caltrans and their Homeless Task Managers on encampments along Highway 1.



Multidisciplinary Outreach Team (MDOT)

- CAT and MDOT assisted a 63 year old unsheltered veteran receive housing with Nation's Finest.
- CAT and MDOT assisted a 65 year old unsheltered veteran obtain housing with the Veteran Transition Center.
- CAT and MDOT assisted an unsheltered male receive dental work. CAT provided transportation for him and Interim provided him with temporary housing.
- CAT members provided multiple unsheltered women with transportation to the Gathering for Women.

Narcan Administered Lifesaving

 MPD responded to an unresponsive male. An MPD officer administered one dose of Narcan with no effect. Monterey Fire and AMR personnel responded and administered more Narcan to the subject and revived the subject.





Case Study - John Doe 1121 (November 2021)

In an effort to explain some of the challenges faced by the MPD in trying to problem solve through a variety of ways, these case studies highlight aspects that the MPD and partners in MDOT face while attempting to resolve issues. This month's case study provides another challenging example.

- John Doe 1121 arrived on the Peninsula around April of 2021 and has been contacted by police nineteen times since then. John Doe 1121 has had four psychiatric evaluation holds placed by the MPD and other peninsula LE agencies, since May 2021. Doe 1121 has had numerous police contacts and arrests with the Eugene (Oregon) Police Department. Since arriving to the Monterey area, the MPD has responded to calls for service with Doe 1121 because people are fearful of his erratic, unpredictable, and nonsensical behaviors. Incidents have occurred in both public and inside private businesses. Doe 1121 has been assaultive to services police and emergency personnel.
- Doe 1121 was honorably discharged from the military where his was a linguist. He is intelligent however suffers from mental health challenges. Doe 1121 was provided assistance through a veteran's program and was provided with housing and financial assistance. Doe 1121 was not allowed to continue in the program because he would not abide by the rules.

Investigations / Monterey Police Anti-Crime Team (IMPACT)

- 11-02-2021- Monterey detectives investigated a sexual assault report in Monterey.
- 11-04-2021- Monterey detectives conducted a probation search at an apartment complex and arrested two residents for maintaining a drug house, possession of a controlled substance, possession of paraphernalia, and possession of a stun gun. Officers also arrested a third subject for warrants.
- 11-09-2021- Monterey detectives arrested two subjects while conducting surveillance in Monterey. One subject was on parole and fled from detectives. After a short foot pursuit, detectives arrested the subject. The second subject was arrested for possessing a controlled substance and a concealed imitation firearm.
- 11-11-2021- Monterey detectives investigated a suspicious death in Monterey. The investigation revealed it was an opioid overdose.



Part I and Part II Crime - October 2021 (as reported to the FBI and pending FBI verification)




Table B- Monthly Average v. November 2021
