

## Drug Enforcement Administration National Prescription Drug Take Back Day

The Monterey Police Department participated in National Prescription Drug Take Back Day on Saturday, October 23, 2021. The MPD set up a booth outside of the police department where members of the community could drop off potentially dangerous prescription medications. The MPD collected a total of 94.5 lbs. of prescription medications to turn over to the DEA. Helping people dispose of potentially harmful prescription drugs is just one way the MPD is working to reduce addiction and overdose deaths.

# Patrol

- 10-02-2021- A victim called to report their credit card had been stolen in Pacific Grove and used at a Monterey motel within an hour of being stolen. MPD officers responded to the motel and contacted the suspect. Officers learned that the suspect was on parole and had an outstanding felony warrant. There was an additional subject in the motel room who was on felony probation. Officers searched the room and located laptops, printers, stolen mail, fraudulent checks, and narcotics. Officers arrested both subjects.
- 10-06-2021- MPD and MFD responded to a structure fire. Officers investigated the incident and discovered that an argument had occurred prior to the fire and the subjects had left. During the officers' investigation, one of the subjects returned and was under the influence of narcotics. The subject confessed to lighting the fire in an attempt to get attention and he was arrested.
- 10-06-2021- Officers responded to a report of a residential burglary in progress. Upon arrival, officers learned that three suspects forced entry into the residence armed with a bat, pipe, and crossbow, and struck three of the victims with the objects and held one victim at bay with the crossbow. Officers learned that one of the victims was the ex-girlfriend of one of the suspects. Officers located one of the suspects and arrested him. The investigation revealed the identities of the other two suspects, who are still outstanding.

- 10-09-2021- MPD aided the MFD and AMR in a water rescue at the Coast Guard Pier. AMR transported the victim from the scene to CHOMP for medical treatment.
- 10-15-2021- MPD officers arrested a suspect for robbery, assault with a caustic chemical and violation of probation after the suspect stole several items from a convenience store, and pepper sprayed the cashier while trying to flee the business.
- 10-15-2021- Officers responded to a road rage incident in which a suspect was leaning out of his passenger window with a BB gun rifle, yelling and challenging the victim. Officers conducted a stop of the vehicle and arrested the suspect.
- 10-16-2021- An adult male on probation was involved in a solo rollover collision in Monterey. When officers arrived, the driver provided a false statement that the driver of the vehicle fled on foot, however multiple witnesses identified him as the driver and solo occupant of the vehicle. The driver refused to comply with his probation terms and refused sobriety testing. Officers transported the subject to CHOMP and obtained a blood sample. Once the subject was cleared from CHOMP, officers arrested and booked the subject at the Monterey City Jail for driving under the influence of alcohol, conspiracy, and probation violation.

## **Patrol Continued**

- 10-16-21- MPD officers responded to a motel for a past-tense armed robbery. Officers located the male victim inside his motel room handcuffed to the shower handlebar. The victim had been held at gunpoint and robbed of his belongings, which included his car key fob, debit card, driver's license and iPhone. The suspect fled the scene in the victim's vehicle. Officers obtained video evidence of the suspect and located the victim's cellular phone in Salinas. MPD coordinated with the Salinas Police Department and SPD located the suspect and arrested him. The suspect was found in possession of an airsoft pistol, a handheld stun gun, the victim's car key fob, debit card, driver's license, iPhone, ATM receipts and cash, drugs/paraphernalia, and evidence of identity theft and fraud. The victim's vehicle was located abandoned in Monterey and recovered by officers. Officers transported and booked the subject at the Monterey County Jail for robbery and other charges.
- 10-19-2021 Monterey Police Officers responded to an intoxicated female refusing to leave a business. When officers arrived on scene, they observed the female strike a male in the face while standing in a parking lot. The male stated he did not know the female, but that she had attempted to enter another person's vehicle without permission and he intervened to stop her. The male declined to pursue charges against the female. Officers arrested the female for public intoxication and she was transported to Natividad Medical Center for medical evaluation due to her intoxication level. During the medical evaluation, the subject kicked an officer twice in the leg, and bit an officer on the forearm with enough force to cause a bite injury through two layers of clothing. Officers booked the suspect into the Monterey County Jail, and added the charge of felony battery on a peace officer resulting in injury.

- 10-21-2021- MPD officers responded to a pedestrian who was struck by a vehicle while crossing Highway 68 attempting to help an injured deer. The vehicle fled the scene. The victim suffered from significant injuries and was transported to Natividad hospital by AMR. Highway 68 was closed for approximately two hours. The investigation is ongoing.
- 10-24-2021- All MPD officers on duty assisted with traffic control due to storm related flooding and trees down.
- 10-24-2021- The Del Rey Oaks Police Department assisted MPD by responding to a burglary alarm at Ryan Ranch, while MPD officers were providing traffic control at various intersections because the power was out due to the storm.
- 10-26-2021- MPD officers responded to a report of a reckless driver who was believed to be under the influence. An officer arrived in the area and attempted to contact the driver, however the driver fled. The officer attempted to stop the driver and observed her going through a red light and turning off her vehicle lights while continuing to flee. The officer pursued the vehicle until the driver turned into a parking lot where the pursuit ended. Officers arrested the driver and booked her into iail for: evading an officer: possession of methamphetamine; and driving under the influence of alcohol.
- 10-28-2021- An MPD officer responded to Seaside PD to assist with Spanish language translation during a domestic violence investigation.
- 10-31-2021- MPD assisted the Monterey Fire Department assist boaters from the ocean after their boat capsized.

# Investigations / Monterey Police Anti-Crime Team (IMPACT)

- 10-05-2021- MPD detectives conducted a probation search on a subject in Sand City. The subject possessed 2 ounces of methamphetamine, approximately 500 hydrocodone pills, various prescription medications without a prescription, and ammunition that the subject was prohibited from possessing. Officers arrested the subject.
- 10-06-2021- Monterey detectives assisted with locating a suspect who was wanted for an assault with a deadly weapon that occurred in Monterey. Detectives located the suspect in Seaside and arrested him. The suspect also was in possession of drug paraphernalia and methamphetamine.
- 10-07-2021- MPD detectives assisted with an arson investigation in Monterey. Detectives coordinated with the Monterey Fire Arson Investigator, re-interviewed the suspect, and brought the suspect back to the scene to verbally walk through his actions, which started the fire.
- 10-11-2021- Monterey detectives completed follow-up on a large amount of stolen mail and personal identifying information. Over the course of two weeks, an additional 50 victims were contacted and identified. Ultimately, officers arrested the two suspects involved in the case.
- 10-13-2021- Monterey detectives conducted an investigation related to a person shot at the skatepark. The investigation revealed the subject succumbed to a self-inflicted gunshot wound.
- 10-18-2021- Monterey detectives conducted an investigation into a robbery. After conducting additional interviews, collection of video surveillance and evidence examination the detectives identified the suspect. Detectives then located and arrested the suspect.

## Community Action Team (CAT)

- Officers provided flyers to homeless persons with information regarding services available to them.

- CAT hosted and participated in the Homeless Monthly Exchange meeting.
- CAT members gave a presentation to children at the San Carlos School.
- CAT members assisted Homeless Task Force managers from Cal-Trans reach out to unsheltered persons located in encampments for resources.

# Multidisciplinary Outreach Team (MDOT)

- CAT and MDOT assisted a 63 year old unsheltered veteran receive housing with Nation's Finest.
- CAT and MDOT assisted a 65 year old unsheltered veteran obtain housing with the Veteran Transition Center.
- CAT and MDOT assisted an unsheltered male receive dental work. CAT provided transportation for him and Interim provided him with temporary housing.
- CAT members provided multiple unsheltered women with transportation to the Gathering for Women.

# Case Study - John Doe 1021 (October 2021)

In an effort to explain some of the challenges faced by the MPD in trying to problem solve through a variety of ways, these case studies highlight aspects that the MPD and partners in MDOT face while attempting to resolve issues. This month we wanted to highlight a case study related to a person who continues to be arrested and reappear in our community as a prolific burglar.


- John Doe 1021 is a 48-year-old male living on the Monterey Peninsula with an extensive history of thefts and burglaries. Doe 1021 moves from one apartment/motel room to another, with no stable living situation. Doe 1021's criminal history began in 1996, with his first arrest for theft in a Bay Area County.
- Since 2007, Doe 1021 has been mentioned, either as a suspect or non-involved person, in 33 reports by the Monterey Police Department. The Monterey Police Department has arrested Doe 1021 (12) times.
- Doe 1021 has been arrested for the following crimes: burglary, attempted burglary, prowling, possession of stolen property, possession of burglary tools, possession of controlled substance, possession of drug paraphernalia, contributing to the delinquency of a minor, possession of marijuana for sale, and cultivating marijuana.
- On multiple occasions, the MPD has conducted probation searches at Doe 1021's storage lockers, or his relative's house. The searches often times result in MPD locating a plethora of property that is later tied to prior burglaries and or thefts around the peninsula.
- Any gap between Does 1021's contacts with local law enforcement tends to coincide with him being in custody. For example, MPD arrested Doe 1021 four times between 2011 and 2013. The next arrest of Doe 1021 by MPD was in 2017, this was because Doe 1021 was sentenced to 7 years (with 27 months suspended, meaning he was not incarcerated during those 27 months) in 2013.
- Between October 2021 and his arrest in November 2021, Doe 1021 was identified as the suspect in four separate burglary and/or prowling cases. Since 2020, Doe 1021 has victimized eight businesses in Monterey. The MPD booked Doe 1021 in jail after arresting him for the burglaries in November 2021. Doe 1021 was released from jail several days after MPD booked him and has a court date in January 2022.



# Narcan Administered Lifesaving

 Officers responded to a traffic collision and found the driver unconscious. An MPD officer administered Narcan and the driver regained consciousness. AMR transported the driver to CHOMP for medical treatment.







Table B- Monthly Average v. October 2021
