## COVID-19 Education / Enforcement

The MPD has actively worked with the Monterey City Code Compliance officers, City Attorney's Office and District Attorney's Office to ensure businesses and individuals were complying with the City, State and County COVID-19 guidelines.

- 02-01-2021 - MPD responded to a group playing soccer at Laguna Grande Park. Officers educated the group on park closures and the group complied and left the park.
- 02-12-21 - A bar was serving food and alcohol indoors. Officers educated and warned the owner. The owner agreed to shut down immediately.
- 02-13-2021 - MPD responded to a bar for violation of the SIP order. The business refused to close. The MPD forwarded the case to the District Attorney's office, Code Compliance and Monterey County Health Department.
- 02-20-2021 - MPD responded to a bar for violation of the SIP order. The business refused to close. Officers forwarded the incident to the District Attorney's Office and Alcohol Beverage Control.
- 02-22-2021 - MPD responded to a group playing soccer at Laguna Grande Park. Officers educated the group on park closures and the group complied and left the park.
- 02-26-2021 - Officers conducted a business check of a bar. Through obstructed windows, officers observed several patrons inside the business. Officers documented the incident with photos and forwarded the case to the District Attorney's Office and Alcohol Beverage Control.

The MPD conducted 45 hours conducting face-covering education and enforcement every weekend, primarily on Cannery Row, Wharf 1, Wharf 2, on the Recreation Trail, and on Alvarado Street.



## Patrol

- 02-03-21- MPD officers aided Marina Police Department in the initial investigation of a shooting that occurred in Marina. The victim of the shooting drove himself to CHOMP to seek treatment for his gunshot wound. MPD officers responded to CHOMP where they secured the victim's vehicle and collected evidence. MPD officers turned the evidence over to Marina PD.
- 02-03-21- A Monterey resident reported being approached by two males with a handgun. As the subjects approached, they indicated the resident was not the person they were looking for and fled on foot.
- 02-04-21- MPD officers were dispatched to a disturbance and as they arrived on scene, the suspect fled in her vehicle. Shortly after the suspect crashed her vehicle, fled on foot and attempted to carjack a witness, but was unsuccessful. Officers arrested the suspect and booked her into Monterey County Jail for driving under the influence, carjacking, hit-and-run, delaying and obstructing officers, and various other charges.
- 02-11-21- An MPD officer attempted to perform a traffic enforcement stop, however the vehicle did not pull over. The driver finally stopped after approximately five blocks and officers determined he had a suspended driver's license. Officers arrested the subject and upon searching him located methamphetamine. A search of the vehicle revealed a disassembled Polymer 80 handgun with no serial number. These types of firearms are often referred to as "ghost guns" as they are very difficult to trace. Officers booked the driver into the Monterey County Jail for possession of undetectable firearm, possession of unloaded firearm in vehicle, driving on suspended driver's license, possession of methamphetamine, failing to yield to police vehicle and driving under the influence. Due to the current Emergency Bail Schedule, the subject's bail was set at \$0 and he was released.
- 02-15-21- MPD officers assisted Pacific Grove Police Department by responding to a domestic violence incident involving a potentially armed, barricaded, subject.
- 02-17-21- MPD patrol officers located a felony vandalism suspect within an hour of receiving an alert from Carmel PD. Carmel PD responded and took custody of the suspect.
- 02-20-21- MPD officers responded to a report of a male attempting to barricade himself in a gas station, who told an employee that someone with a gun was chasing him. Prior to officers' arrival the subject left in a vehicle. Shortly afterward, the subject was travelling on Del Monte near the Navy gate, crossing over into oncoming traffic to pass traffic, when he lost control and struck a telephone pole. The suspect fled on foot to a coffee shop and ran into the bathroom. Officers located the subject in the bathroom and began discourse and established a rapport with the suspect. The suspect eventually exited the bathroom and was taken into custody without incident.
- 02-21-2021- MPD officers located a stolen vehicle from Fresno at a local motel. Officers arrested two subjects, searched the vehicle and located a handgun with an extended magazine and illicit drugs in the vehicle. Officers booked the subjects for possession of a stolen vehicle, possession of an unregistered firearm, burglary and various drug charges.
- 02-23-2021- MPD officers investigated a report of domestic violence in Monterey wherein the suspect stole his girlfriend's car after battering her. After identifying the suspect, officers learned he had two out-of-county felony warrants for his arrest. The California Highway Patrol (CHP) located the suspect driving the stolen vehicle near Marina. The suspect did not pull over and the CHP pursued him to Castroville where he fled on foot. The CHP and Monterey County Sheriff's Office coordinated a search and located the suspect and turned him over to Monterey Police Department.
- 02-26-2021- MPD responded to a local business on the report of a subject stealing merchandise and refusing to comply with the store employee who was trying to stop him. MPD officers were able to locate the suspect and arrested him.



## Community Action Team (CAT)

- Encampment Noticing & Abatement
  - Noticed (20) encampments
  - Abated (17) encampments

  - Officers provided flyers to homeless persons with information regarding services available to them.
- CAT members conducted patrols at the Old Capital Site and Fort Ord Property
- CAT members teamed up with patrol to perform a birthday drive-by for a 7-years old.
- CAT conducted 10 hours of bicycle patrol throughout the City.

## Multi Disciplinary Outreach Team (M.D.O.T.)

- CAT members transported a mentally ill homeless individual to Monterey County Behavioral Health for an appointment.
- CAT members transported a homeless subject to the Salvation Army for an ID voucher.
- CAT members transported a homeless subject to the DMV so he could obtain an ID.
- CAT members transported a homeless person to the warming shelter in Salinas.
- MDOT/ YWCA assisted a homeless subject obtain a bus pass to Los Angeles.
- MDOT/ Adult Protective Services assisted a homeless subject with resources.
- CAT assisted an individual verify his Medi-Cal coverage and assisted him in scheduling an intake appointment with Genesis House for rehabilitation.



## Investigations

- 02-01-21- MPD Patrol officers arrested and booked a subject. When the subject was released from jail he threatened to kill the police officer that arrested him. MPD Detectives started an investigation and attempted to locate the suspect and determined the subject was arrested by Los Angeles PD with several firearms.
- 02-17-21- MPD Detectives located and arrested a subject who fled from Pacific Grove PD the previous night and was suspected of committing several burglaries.
- 02-17-21- MPD Detectives located a subject wanted for domestic violence, assault with a deadly weapon and felony vehicle pursuit from Marina. The suspect barricaded himself inside a vehicle. MPD Detectives and patrol officers were able to establish a dialogue with the subject and after approximately 20 minutes he surrendered to officers.
- 02-19-21- MPD Detectives tracked a subject to Pacific Grove who was wanted for robbery. Prior to making contact with the subject, detectives coordinated with the Pacific Grove Police Department and established a perimeter. When officers tried to contact the suspect he tried to flee the property but perimeter officers were able to take him into custody.
- 02-24-21- MPD Detectives conducted a residential burglary investigation, identified a suspect and obtained evidence connecting him to the burglary.
- 02-24-21- MPD Detectives were conducting surveillance which led to locating an out of county sex registrant who was on parole and driving on a suspended license.

## Narcan Administered Lifesaving

- 02-20-21- MPD Officers were dispatched to an unconscious male who did not appear to be breathing. After speaking with a witness, officers learned that the male likely overdosed and they immediately administered one dose of naloxone, followed by three additional doses when he did not regain consciousness. The male started breathing and the officers continued to administer aid until the Monterey Fire Department and AMR personnel arrived. Shortly thereafter, the male regained consciousness.
- The MPD administered Narcan on three other occasions during the month.






