Citizen Commendation

"I am a so-called "senior citizen," in my early 80's and want to applaud you all for helping me today. This afternoon, after I had gotten a haircut, I searched the area for my car and couldn't find it. I had forgotten where I parked it and was rather appalled by this, didn't know what to do; I walked many streets for several hours looking but didn't find it. I called you all, explained my situation, and gave you the description and year of my car and you told me to wait and a police car would search the area where I thought I had parked my car. After waiting about an hour, indeed along comes a police cruiser, and the two officers cheerfully said, "We found your car!" I got in, and we went to a totally different area than I had remembered I had parked and there was my car. Thank you so much to the two officers who were also very kind. This problem of mine was very simple, really, unlike some of the issues I am sure you all must deal with. I find myself very grateful for you all and in particular today; who knows how much longer (and how much colder!) I would be without your help."





Patrol

- 12-01-2022- MPD attempted to contact a burglary suspect. The suspect fled from officers and side-swiped a parked vehicle. A short pursuit ensued, but the suspect was able to escape.
- 12-01-2022- MPD detectives attempted to contact a possible armed suspect on post prelease community supervision with a no-bail warrant. The suspect fled from officers and was ultimately apprehended.
- 12-03-2022- An MPD officer working the midnight shift on patrol heard several gunshots and saw a truck drive past him shortly after. The officer stopped the vehicle occupied by two suspects, and located one used .40 caliber shell casing, an empty holster and one empty shell casing in the vehicle. Officers found two additional casings on the roadway and obtained video surveillance footage of the intersection where the gunshots were fired. The video surveillance had audio of the gunshots coming from the suspect vehicle. Officers arrested the vehicle occupants for negligent discharge of a firearm, carrying a loaded firearm in public, post-release community supervision violation, and prohibited possessor.
- 12-09-2022- Officers responded to a vehicle versus pedestrian hit-and-run collision, which resulted in injury. The victim sustained a severe laceration to the back of her calf and minor injuries to her head and shoulder. Officers identified the vehicle make and color from a damaged side mirror left at the scene. Officers later located the vehicle in Monterey with fresh damage, a missing mirror, and dried blood on the front fender. Officers impounded and secured the vehicle. The following day detectives investigated the incident and contacted the suspect. The suspect provided a statement and officers arrested and booked the suspect.

- 12-10-2022- MPD assisted CHP with a single-vehicle collision after a sedan traveling on Hwy. 1 south lost control and left the roadway down an embankment. The vehicle struck a tree and rolled onto its hood coming to rest on the ramp to Hwy 1 south at Munras. The driver and single occupant suffered injuries and AMR transported them to Natividad Medical Center. MPD provided aid and closed the off-ramp until CHP arrived.
- 12-10-2022- MPD assisted CHP with a downed tree on Hwy 1 blocking all lanes of traffic in darkness. CHP was unable to send any units. MPD officers secured the highway and diverted traffic around the hazard until Cal Trans arrived on the scene to remove the tree.
- 12-16-2022- Navy PD located an unoccupied damaged vehicle in their jurisdiction. MPD officers assisted and determined that the vehicle was involved in a solo collision with a telephone pole.
- 12-16-2022- MPD responded to several complaints regarding a large group of bicyclists committing violations in various parts of the peninsula. Officers witnessed the group committing lighting, helmet, impeding, crossing into oncoming traffic, and red-light violations. MPD officers stopped and cited one of the subjects for violations and released the rider to their parents.
- 12-18-2022- MPD received a report from a guest at a
 Monterey lodge that a group of subjects attempted to
 enter her room. Officers found four suspects on the
 scene. One suspect fled and jumped the back fence of
 the hotel. Officers detained the other three subjects.
 Officers located the suspect who fled and arrested him
 for possessing burglary tools, drug paraphernalia, and
 PRCS violation. Officers released the other three
 subjects.

Community Action Team (CAT)

 The Multidisciplinary Outreach Team (MDOT) helped identify several families needing assistance this season. With donations from the Monterey Rotary Club and MPD staff, the CAT team purchased and delivered gifts for the families in need.

Narcan Administered Lifesaving

- MPD responded to an unresponsive male subject. The first officer on scene recognized the subject was suffering from a drug overdose and administered a dose of Narcan. The Narcan revived him, and AMR transported him to CHOMP for further care.
- Monterey Fire Department administered two doses of Narcan to an unresponsive male. After regaining consciousness, AMR transported the subject to CHOMP for further evaluation and treatment.
- Monterey Fire Department administered three doses of Narcan to an unresponsive male. After regaining consciousness, AMR transported the subject to CHOMP for further evaluation and treatment.
- An MPD officer and Monterey Fire Department administered two doses of Narcan to an unresponsive unhoused male. After regaining consciousness, the subject declined transportation to CHOMP for evaluation and treatment.



Multidisciplinary Outreach Team (MDOT)

- An unhoused male with a substance abuse addiction requested shelter services. Officers transported him to the sobering center.
- CAT participated in a bi-monthly meeting regarding SURT (Substance Use Response Team).
- CAT assisted an unhoused female with an inclement weather motel voucher.
- CAT assisted an unhoused female with a three-day inclement weather motel voucher.
- CAT assisted an unhoused male with a two-day inclement weather motel voucher.
- CAT/MDOT assisted an unhoused female with resources and transportation to I-Help for Women.
- CAT assisted an unhoused female suffering from medical issues with transportation to various appointments during the holidays.
- CAT transported an unhoused female to the Sobering Center for assistance and set up an assessment with the Door to Hope for housing.
- CAT conducted a ride-along with the Substance Use Response Team to provide outreach.
- CAT assisted the Coalition of Homeless Services with transportation for an unhoused female to retrieve an inclement weather voucher for a motel room.
- CAT/ MDOT assisted a victim of domestic violence/sexual assault with shelter options through YWCA.
- CAT acquired sleeping bags and jackets from St.
 Vincent DePaul and handed them out to the locally unhoused.




Investigations / Monterey Police AntiCrime Team (IMPACT)

- 12-01-2022- Detectives conducted a probation search and arrested the suspect for possession of controlled substances, burglary tools and resisting arrest.
- 12-06-2022-Detectives investigated two subjects who shot a firearm out of their vehicle while driving in Monterey. Detectives arrested both suspects and impounded their vehicle.
- 12-07-2022- Detectives followed up on a series of vandalisms wherein the suspect etched the windows of four businesses causing thousands of dollars in damage.
- 12-08-2022- Detectives investigated a sexual assault case. The investigation is ongoing.
- 12-09-2022- Detectives investigated a hit-and-run involving a vehicle versus a pedestrian. Detectives arrested the driver of the vehicle.
- 12-09-2022- Detectives investigated a phone and text scam.
- 12-10-2022- Detectives investigated credit card fraud that occurred at a hotel.
- 12-12-2022- Detectives investigated an assault. The investigation is ongoing.
- 12-12-2022- Detectives assisted patrol with the investigation of a DUI collision.
- 12-13-2022- Detectives investigated a hit-and-run car accident.

- 12-13-2022- Detectives followed –up on threats a suspect made over the internet. Officers contacted the suspect and obtained a Gun Violence Restraining

 Order
- 12-13-2022- Detectives investigated a report of theft via an online Crypto wallet. The investigation is ongoing.
- 12-20-2022- Detectives investigated a report of financial elder abuse. Detectives identified the suspect and forwarded the case to the District Attorney's Office.
- 12-21-2022- Detectives investigated a physical assault and located and arrested the suspect.
- 12-22-2022- Detectives investigated a sexual assault case. The investigation is ongoing.
- 12-27-2022- Detectives investigated a fraud case that occurred over PayPal.
- 12-28-2022- Detectives investigated check-fraud from a Monterey business. Detectives identified a suspect and forwarded the case to the District Attorney's Office.
- 12-28-2022- Detectives investigated a fraud case and identified and arrested the suspect. The investigation revealed the suspect stole a Monterey resident's identity and possessed stolen property from multiple thefts in Monterey. Detectives forwarded the case to the District Attorney's Office.
- 12-28-2022- Detectives investigated a theft of a bicycle from a residence. The investigation is ongoing.
- 12-29-2022- Detectives conducted a probation search in Seaside and arrested the suspect for possessing a controlled substance.
- 12-29-2022- Detectives investigated two burglaries in Monterey and identified and arrested the suspect in Seaside.
- 12-29-2022- Detectives investigated possible fraud that occurred over SnapChat. The investigation is ongoing.
- 12-30-2022- Detectives investigated potential bank fraud. The investigation is ongoing.
- 12-30-2022- Detectives investigated a potential embezzlement from a local business. The investigation is ongoing.
- 12-30-2022- Detectives arrested a male suspect for being under the influence of a controlled substance and resisting arrest.



Case Study - Jane Doe 1222 (December 2022)

In an effort to explain some of the challenges faced by the MPD in trying to problem solve through a variety of ways, these case studies highlight aspects that the MPD and partners in MDOT face while attempting to resolve issues. This month's case study provides another challenging example.

Jane Doe 1222 is a 39-years old unhoused individual. Doe 1222 has had 156 police contacts and arrests since 2013. DOE's arrests include prostitution, drug sales, use of controlled substances and peace disturbances. Doe 1222 has had mental health evaluations.

Doe 1222 suffers from mental illness and when she fails to utilize her medication, she becomes very aggressive toward the community and law enforcement. Doe 1222 has been placed on numerous psychiatric evaluations. Some of DOE'S behaviors include walking in the middle of the street and loitering in private businesses. Doe 1222 has recently gone partially blind. Numerous calls for services for welfare checks have been conducted based on DOE'S appearance and catatonic state. Doe 1222 has been put in touch with Mobile Crisis and has been transported to the Gathering for Women to utilize services.

Some of Doe 1222 arrest history includes:

- 2022- Trespass and an outstanding warrant
- 2021- Trespass with stay away order on Del Monte and probation violation
- · 2021- Resisting/Obstructing a peace officer
- · 2021- Trespassing
- 2019- Theft
- 2019- Resisting/Obstructing a Peace officer
- 2019- Possession of a Controlled Substance
- 2019- Burglary
- 2018- Possession of a Controlled Substance
- 2017- Theft of property

Doe 1222 associates and loiters in downtown Monterey and the N.Fremont District. Doe 1222 has denied numerous services to assist her with obtaining shelter and substance abuse rehabilitation.

The MDOT team interacts with DOE 1222 on a constant and consistent basis. Doe 1222 has been connected with Behavioral Health and has refused services. MPD has driven Doe to various service providers for shelter and provided her with phone access and assistance in outreach to service providers.



National Incident Based Reporting System

The Monterey Police Department (MPD) transitioned to the California and National Incident-Based Reporting Systems (CIBRS and NIBRS) on March 1, 2022 and has completed the required three (3) month validation period. CIBRS and NIBRS reporting meets state and federal data standards and supports the national transition to NIBRS. As the new data collection standard, NIBRS captures all offenses within an incident – up to ten crime occurrences, representing a substantial shift in crime reporting. The additional detailed crime incident data provides greater analytic capability and makes NIBRS a superior crime-reporting method when compared to the previously utilized Uniform Crime Reporting (UCR) standard. MPD has fully transitioned to NIBRS reporting and discontinued UCR reporting.

This new reporting yields a different format for data collection and is divided into Group A and Group B offenses. Group A offenses are the more serious crimes such as Murder, Rape, Robbery, etc. Group B offenses tend to be minor offenses, such as Curfew, Loitering and Vagrancy Violations, Disorderly Conduct, and Driving Under the Influence.

The data is grouped into three (3) crime categories of Crimes Against Persons (counted per victim), Crimes Against Property (counted per incident), and Crimes Against Society (counted per crime against society). Crimes against persons include assault, homicide, human trafficking, kidnapping and sex offenses. Crimes against property include robbery, burglary, larceny-theft, motor vehicle theft, and arson. Crimes against society include drug/narcotic offenses, gambling, pornography, prostitution, liquor law violations, disorderly conduct, peeping tom, curfew/vagrancy violations, trespassing, driving under the influence, and weapon law violations.


Law enforcement agencies report data from each offense and arrest for Group A offenses, but report only arrest data for Group B offenses. There are more offenses reported in NIBRS, more details per incident, and arrests and offenses linked in NIBRS.
