

# MONTHLY REPORT

## MPD Commendation

Monterey Police Officers responded to a report of an interrupted burglary at an occupied residence. Officers contacted the victim and began investigating the incident. The victim described that she observed an unknown male standing atop a patio chair, that the suspect had hoisted onto the roof, and was attempting to gain access through the window of her room. The victim confronted the suspect and the suspect fled on foot. The victim gave a description of the suspect to officers. Officers searched the surrounding area. During their search officers located a subject matching the suspect description and detained the suspect. Officers determined the suspect was on felony probation for burglary and had several prior arrests. The suspect was also in possession of burglary tools. Officers arrested and booked the suspect. The suspect's actions were likely to continue had it not been for the quick investigative thinking and the collaborative efforts of the officers and the initial report by the community member.

## Patrol

- 02-05-22- MPD responded to a report of a group of juvenile subjects brandishing a firearm on Wharf 2. Officers detained and searched the subjects and located an imitation firearm on the waistband of one of the subjects. Officers determined the subject had two warrants for prior charges related to bringing weapons to school and was reported as a missing juvenile from Seaside. Officers detained the juvenile and transported him to juvenile hall. The other subjects were transported to the MPD where they were released to their guardians on citations for curfew violations.
- 02-06-22- A Monterey resident reported that her roommate pointed a handgun at her and threatened her inside their residence. MPD responded, set up a perimeter and utilizing de-escalation techniques negotiated with the occupants to exit the home. All of the occupants were detained and questioned by officers and after the investigation the officers arrested the suspect.
- 02-08-22- MPD Officers arrested a suspect for domestic battery. The suspect was intoxicated and yelling when he was arrested. While transporting the suspect to the Monterey Police Department, the suspect began kicking the door and banging his head against the vehicle. When the suspect exited the vehicle at the police department, he head-butted an officer. Officers utilized a seated restraint device to transport the suspect to be booked at the Monterey County Jail.
- 02-13-22- MPD officers responded to a physical altercation in Monterey. During the altercation, one of the subjects was stabbed multiple times and ultimately died as a result of the stabbing. All patrol officers that were working, responded to the scene and closed off the streets to establish a crime scene. The entire MPD investigations division was called back as were staff that had previously worked as detectives. Multiple leads were followed, and many allied agencies have assisted with the investigation. The homicide investigation is on-going.
- 02-14-22- An officer observed a traffic violation and initiated a traffic stop. The vehicle failed to yield, and the officer briefly pursued the vehicle before the driver stopped. The officer arrested the driver for driving under the influence and failing to yield. The driver had prior DUI arrests and was on probation.



- 02-18-22- MPD responded to a report of a subject who was unhappy about work taking place outside of her residence. When officers arrived, the subject had grabbed onto the basket lift and refused to let go, halting the work. The MPD officers spoke with the subject for approximately 20 minutes finally convincing her to let go of the basket lift and the work was able to resume. MPD officers documented the subject's concerns in a report.
- 02-18-22- MPD responded to a report of a vehicle that ran over a pedestrian's foot at Soledad and Pacific causing injury. An ambulance transported the pedestrian to CHOMP for treatment. MPD conducted an investigation into the incident.
- 02-26-22- MPD officers responded to a call of a "road-rage" incident. The victim reported that the suspect pointed a gun at him. Through the investigation the officers were able to determine the suspect vehicle. Officers conducted follow-up and were able to locate the vehicle in Pacific Grove. Officers made contact with the driver and found a gun in a backpack in his car. The officers arrested the suspect for exhibiting a deadly weapon.

## Narcan Administered Lifesaving

- MPD responded to a 46-year-old male who overdosed on opiates. Monterey Fire Department administered one dose of Narcan. AMR transported the subject to CHOMP.





## Community Action Team (CAT)

- Encampment Noticing & Abatement
  - Abated (68) encampments
    - (52) Del Monte Beach; (9) Window on the Bay; (2) Don Dahvee Park; (4) Visitor's Center; (1) Pearl/ Green Belt.
- Officers provided flyers to homeless persons with information regarding services available to them.

## Multidisciplinary Outreach Team (MDOT)

- CAT/MDOT assisted a subject recovering from COVID-19 obtain a cell phone, enabling the subject to keep up with Adult Protective Services appointments.
- CAT assisted an unhoused female obtain necessities from Gathering for Women.
- CAT/ MDOT met with the family of a mentally ill person, whose recent behavior elicited a large police response. CAT and Monterey County Behavioral Health offered resources to the family and discussed developing a short-term and long-term plan for their family member.
- CAT assisted Interim locate a patient whom they were trying to schedule for an assessment.
- CAT transported a chronic unsheltered person with a substance abuse problem to Sun Street Rehabilitation Center in Salinas.
- CAT met with Monterey County to discuss and obtain Inclement Weather Vouchers to provide to those in need.
- CAT transported a newly unhoused person to the Salvation Army to obtain resources.

## Investigations / Monterey Police Anti-Crime Team (IMPACT)

- 02-03-22- MPD detectives received information regarding potential violence in a workplace. Detectives obtained a gun violence restraining order and a search warrant for the suspect's residence. Detectives served the warrant, and during their search recovered an assault rifle, a "ghost gun" pistol, ammunition, and a pepper ball gun. Detectives arrested the suspect for violation of the court order and possession of the prohibited weapons.
- 02-09-22- Monterey detectives assisted patrol respond to a report of a man with a gun in Monterey. Detectives assumed the investigation. The suspect was ultimately placed on a mental health hold.
- 02-13-22 – The entire MPD Investigations Unit and additional staff that had previously been assigned to investigations, were called back to assist in the investigation of a homicide that occurred on Alvarado Street. The incident occurred after an altercation with multiple subjects that resulted in the stabbing of the victim. The MPD is continuing to investigate this crime.



## Case Study - John Doe 0222 (February 2022)

In an effort to explain some of the challenges faced by the MPD in trying to problem solve through a variety of ways, these case studies highlight aspects that the MPD and partners in MDOT face while attempting to resolve issues. This month's case study provides another challenging example.

- John Doe 0222 is a 41-years old unhoused individual. While he is from Monterey, there is a stay away order prohibiting him from being at the family home. Since 2002, the Monterey Police Department has had 118 local contacts with Doe 0222. The contacts include arrests for violations of the law to include violation of protection orders, resisting arrest, drug possession and use, etc. Doe 0222 has also had multiple psychiatric evaluations.
- Doe 0222 is aggressive toward police officers when they contact him due his alcohol, drug and mental instability. Since 2020, Doe 0222 has been arrested (7) times for restraining order violations and been placed on a psychiatric evaluation (3) times. Since 2003, Doe 0222 has been placed on psychiatric evaluations (7) times. It is important to note that for a variety of reasons, arrests do not always result in criminal prosecution. At least four cases over a 16-month period in 2020-2021 were dismissed. Doe 0222 was most recently arrested in February 2022.

- Doe 0222 is currently on probation with eighteen conditions for a case that occurred in 2020 for false imprisonment and criminal threats. He has one active case currently pending for violating a court order and drug possession. Doe 0222's probation conditions include things such as: obey all laws, not commit same/similar offense, not drink or possess alcoholic beverage, submit to search, etc.
- Doe 0222 is service resistant. MPD has continuously tried to obtain services for Doe 0222 and on one occasion, he was enrolled in a program, but opted out after a short period of time.

As this case study shows, the criminal justice system is lacking, the mental health system is lacking, and Doe 0222 is resistant to any type of assistance that can be provided.

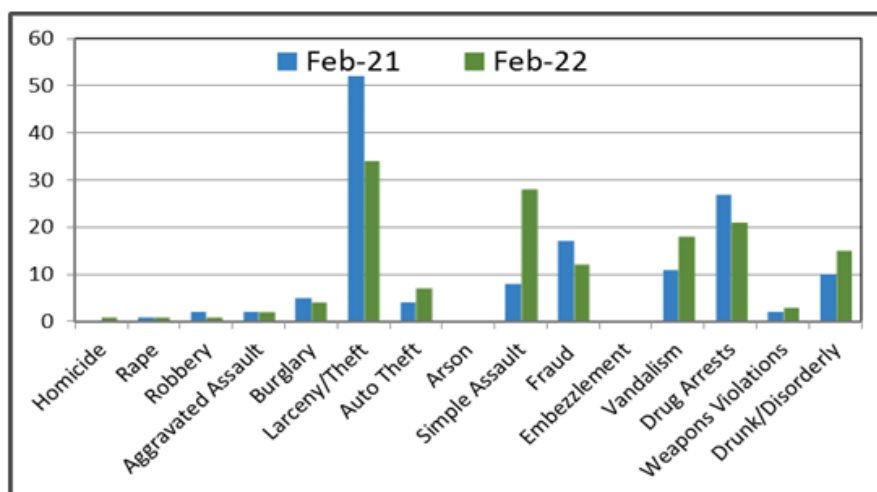
