## MONTEREY POLICE DEPARTMENT



### MPD Commendation

**July 2022:** An MPD traffic officer learned of fentanyl sales occurring at a Monterey hotel. Utilizing his previous narcotics investigation experience, the officer gathered a team to assist him in his investigation. The officers gathered enough intelligence & information to author a search warrant for the suspected dealer's person, vehicle, & hotel room. By the time the warrant was signed, it was in the evening & the officers were at the end of their shifts. The officers learned the suspect had left Monterey to get a resupply of fentanyl. The officers recognized that if they were able to intercept the suspect as he returned, they would be able to seize all of the resupply before any of it made it onto the streets. However, officers did not know when the suspect would return & presumed it would not be until hours later in the evening.

Rather than pausing the investigation to resume it the next day during normal work hours, these officers chose to continue working the case. The officers conducted surveillance of the suspect's home & surrounding area. Several hours later, officers located & detained the suspect. Officers served the search warrant & located over a quarter pound of fentanyl & one ounce of methamphetamine. The officers had in fact intercepted the dealer & seized his entire resupply. The officers are commended for their teamwork and dedication by going beyond MPD's already high-performance expectations. By the time evidence was booked & reports written, the officers had worked well over 24 consecutive hours.



## Patrol

- 07-07-2022- An MPD traffic officer initiated a traffic stop of a vehicle after observing the driver not wearing a seatbelt. The driver was also smoking marijuana. When officers searched the car, they located a loaded assault rifle with no serial number and a high-capacity magazine. Officers arrested the driver.
- 07-07-2022- MPD responded to a report of a missing elderly woman with dementia who walked away from CHOMP. MPD utilized reverse 911, activated CERT, and sent Nixle and social media alerts to help locate her. A security officer at a Salinas business reported that he located an individual matching her description. Salinas PD responded and positively identified the subject and transported her to Monterey. Monterey Police Officers met Salinas PD and transported her to CHOMP, where she was reunited with her family.
- 07-07-2022- An MPD officer stopped a vehicle for expired registration. During the traffic stop, the officer noticed an open bottle of beer in the center console and asked the driver to exit the vehicle. The officer further observed a large bag of marijuana in the vehicle. During the search of the vehicle, officers located a bicycle that had been reported stolen to the Pacific Grove Police Department. Officers ultimately arrested the subject for possession of 8.5 oz. of marijuana, stolen property, misappropriation of found property, driving without a license or proof of insurance.
- 07-12-2022- Officers responded to a solo vehicle injury accident. AMR transported the driver to Natividad Hospital for major injuries. Officers had the vehicle towed from the scene.
- 07-15-2022- MPD received a report that a landscaper located a firearm in bushes in a commercial area in Monterey. The investigation is ongoing.
- 07-15-2022- MPD responded to a physical fight. Officers arrived on scene and located a male victim unconscious with serious facial injuries laying in the middle of the street. AMR transported the victim to Natividad Medical Hospital. Officers pursued the male suspect on foot until ultimately arresting him for assault with a deadly weapon and resisting arrest.
- 07-20-2022- A delivery driver left their car running while making a delivery. The driver's vehicle was taken by an unknown suspect. MPD coordinated with Monterey County law enforcement agencies to try and locate the stolen vehicle but were unsuccessful. The investigation is ongoing.
- 07-20-2022- The city experienced intermittent power outages causing major intersection traffic lights to go down. The MPD sent out alerts to the community via Nixle and social media.
- 07-24-2022- MPD responded to a physical fight between two subjects in Monterey. Officers' investigation determined that one of the subjects confronted the other about digging through garbage cans in the parking lot. The subjects engaged in a physical fight and one subject struck the other with a hammer. AMR transported the subjects to Natividad hospital for medical treatment. After medical clearance, officers arrested one of the subjects for elder abuse, theft, and probation violation.
- 07-25-2022- MPD responded to a retail theft. Three suspects entered a business and stole approximately \$60,000 in merchandise. The suspects fled the scene. The investigation is ongoing.





## Patrol Continued

- 07-25-2022- MPD responded to a report of an attempted theft. The elderly victim reported that the suspect entered her business and was acting suspicious. While attempting to locate the suspect in the store, she found the suspect with his hand in her purse. The victim confronted the suspect, and the suspect grabbed her and threw her towards a table, causing her to fall over, and hit her head on a table. The investigation is ongoing.
- 07-26-2022- MPD responded to a past tense discharge of a firearm into an apartment. Officers contacted the tenant responsible for the discharge. MPD investigations collected four firearms for safekeeping.
- 07-29-2022- MPD, MFD, and AMR responded to a vehicle injury collision on Highway 68. The roadway was closed for approximately 30 minutes.
- 07-30-2022- MPD responded to a report of a mother periodically leaving her toddler unattended. Officers investigated the circumstances and learned that the mother had left her child unattended for approximately 10 hours. Officers arrested the mother for child neglect. Child protective services took custody of the toddler.
- 07-30-2022- MPD responded to a felony DUI hit-and-run in which a vehicle struck a pedestrian. The victim sustained injuries. Officers arrested and booked the driver at jail.

## Investigations / Monterey Police Anti-Crime Team (IMPACT)

- A Monterey Police Reserve officer and member of the Monterey County District Attorney's Cold Case Task Force, was instrumental in solving a cold case homicide that occurred in Seaside, CA over 40 years ago.
- 07-05-2022- Monterey detectives investigated a possible child abuse case in Monterey. Detectives conducted a forensic interview.
- 07-16-2022- Monterey detectives investigated an assault. Detectives assisted with interviews and crime scene processing.
- 07-26-2022- Monterey detectives investigated a shooting that occurred in Monterey. The investigation revealed that the shooting was a negligent discharge of a firearm. Detectives seized four firearms as evidence and forwarded the case to the District Attorney's Office for charges.

## Narcan Administered Lifesaving

- 07-07-2022- MPD officers responded to a Fentanyl overdose at the Transit Plaza. AMR administered Narcan, reviving the subject, and transported the subject to the hospital for treatment.



## Community Action Team (CAT)

- Encampment Noticing & Abatement
  - Abated (105) encampments
    - (82) Del Monte Beach; (10) Window on the Bay; (1) Calle Principal and Jefferson; (3) Camino El Estero Park Complex; (2) Tenth and Park; (2) Recreation Trail at Hannon; (3) Iris Canyon and Via Mirada; (2) Waterfront.
    - Officers provided flyers to homeless persons with information regarding services available to them.
- 07-14-2022- MPD command and CAT team officers attended the Lead Me Home Summit on Homelessness, which brought together local leaders, decision makers, and experts to examine issues related to those experiencing homelessness on the Monterey Peninsula.
- CAT gave a presentation to youth campers at Whispering Pines Park
- CAT hosted and participated in the monthly City liaison meeting.

## Multidisciplinary Outreach Team (MDOT)

- CAT/MDOT participated in Coffee with a Cop.
- CAT participated in meetings regarding the SURT (Substance Use Response Team)
- CAT transported an unhoused male to the Department of Social Services office in Seaside to activate his Medi-Cal and food stamps.
- CAT assisted an unhoused male reunite with his family in Minnesota.
- CAT assisted an unhoused male with re-entry into the program at the Veteran Transition Center after relapsing into alcohol addiction.
- CAT assisted an unhoused male in setting up an appointment with behavioral health and transportation to CHOMP on a self-committal.
- CAT transported an unhoused male to CHOMP to begin alcohol detox.
- CAT assisted two unhoused males with a phone assessment for the Genesis House.
- CAT assisted an unhoused female with transportation to the Gathering for Women.





## Case Study - John Doe 0722 (July 2022)

In an effort to explain some of the challenges faced by the MPD in trying to problem solve through a variety of ways, these case studies highlight aspects that the MPD and partners in MDOT face while attempting to resolve issues. This month's case study provides a challenging example that resulted in a positive outcome.

- John Doe 0722 is a 47-years old unhoused individual. Doe 0722 has had over 100 police contacts since 2014. Twelve of those contacts resulted in arrests. On two occasions he was transported to a medical facility for a psychiatric evaluation. Most of the issues have revolved around substance abuse.
- Doe 0722 is very cooperative with police, however he generates many calls for service due to his erratic behavior and propensity to collect a high volume of unusual objects and carry them around with him while he erects illegal encampments.

Recently, Doe 0722 approached members of CAT/MDOT about reuniting with his family out of state. CAT/MDOT was able to contact family members who were receptive to receiving Doe 0722. CAT/MDOT made arrangements to successfully reunite Doe 0722 with his family.

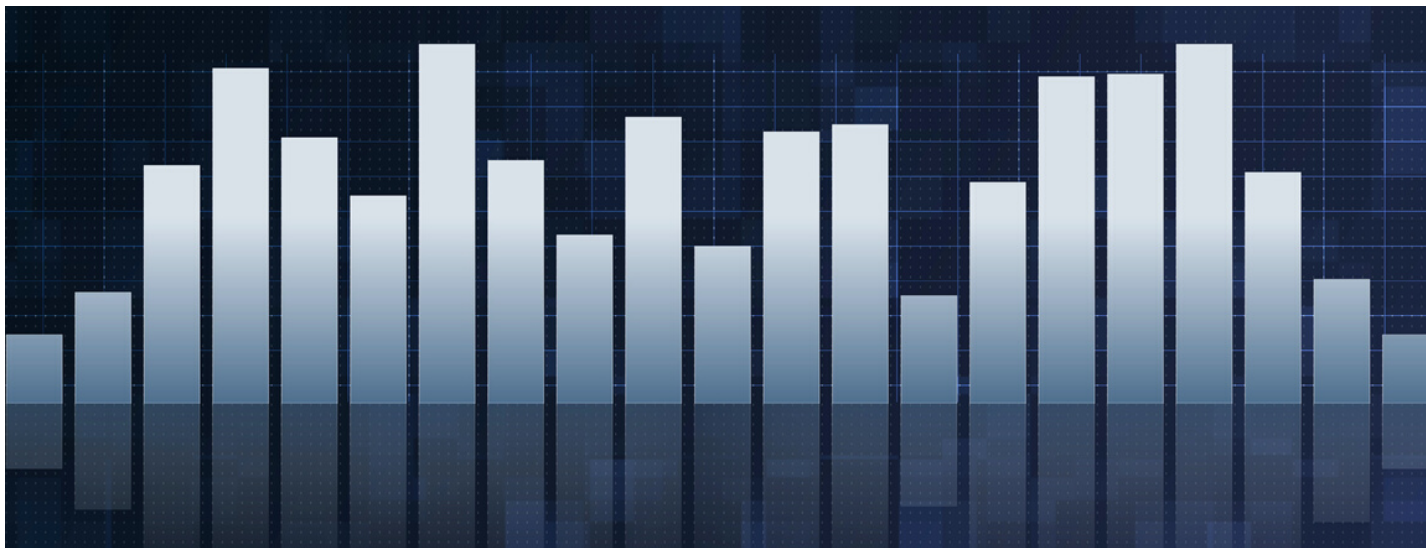

## National Incident Based Reporting System

The Monterey Police Department (MPD) transitioned to the California and National Incident-Based Reporting Systems (CIBRS and NIBRS) on March 1, 2022 and has completed the required three (3) month validation period. CIBRS and NIBRS reporting meets state and federal data standards and supports the national transition to NIBRS. As the new data collection standard, NIBRS captures all offenses within an incident – up to ten crime occurrences, representing a substantial shift in crime reporting. The additional detailed crime incident data provides greater analytic capability and makes NIBRS a superior crime-reporting method when compared to the previously utilized Uniform Crime Reporting (UCR) standard. MPD has fully transitioned to NIBRS reporting and discontinued UCR reporting.

This new reporting yields a different format for data collection and is divided into Group A and Group B offenses. Group A offenses are the more serious crimes such as Murder, Rape, Robbery, etc. Group B offenses tend to be minor offenses, such as Curfew, Loitering and Vagrancy Violations, Disorderly Conduct, and Driving Under the Influence.

The data is grouped into three (3) crime categories of Crimes Against Persons (counted per victim), Crimes Against Property (counted per incident), and Crimes Against Society (counted per crime against society).

Crimes against persons include assault, homicide, human trafficking, kidnapping and sex offenses. Crimes against property include robbery, burglary, larceny-theft, motor vehicle theft, and arson. Crimes against society include drug/narcotic offenses, gambling, pornography, prostitution, liquor law violations, disorderly conduct, peeping tom, curfew/vagrancy violations, trespassing, driving under the influence, and weapon law violations.

Law enforcement agencies report data from each offense and arrest for Group A offenses, but report only arrest data for Group B offenses. There are more offenses reported in NIBRS, more details per incident, and arrests and offenses linked in NIBRS.
