MPD Commendation

In late October 2022, an MPD detective learned that a suspect was illegally selling firearms out of his vehicle. MPD detectives set up surveillance and learned the suspect's identity and vehicle description. Detectives developed a plan to serve a search warrant on the suspect and his vehicle. Seaside Police Department detectives volunteered to assist MPD with surveillance. Later that evening, detectives located and detained the suspect in Seaside. Detectives searched the suspect's vehicle and located four firearms, two of which the suspect stole from other jurisdictions. Detectives arrested the suspect for being a felon in possession of firearms, possession of ammunition, stolen property, destructive device and drug paraphernalia, destruction of a firearm's serial number, and committing a felony while out on bail. The officers involved in this case exemplified great tactics, communication, teamwork, investigative skills, and professionalism that led to the successful apprehension of a potentially violent felon.

Patrol

- 10-01-2022- MPD arrested a suspect for felony vandalism.
- 10-02-2022- A vehicle crashed into a power-pole causing a wildland fire in the County area, just outside of Monterey. The driver fled the scene and MPD officers assisted the Monterey County Sheriff's Office search for the driver and provide evacuation notices to residents whose homes were threatened by the fire. The MPD, CHP and MCSO searched for and located the driver who was suffering from various injuries.
- 10-03-2022- MPD responded to a report of a suspect who brandished a firearm and broke a victim's car window with an unknown object. Officers were not able to locate the suspect. The investigation is ongoing.
- 10-04-2022- MPD responded to small fire at the base of a tree and a second fire in a garbage can. The Monterey Fire Department extinguished both fires. It appeared both fires were caused by arson and the investigation is continuing.
- 10-05-2022- MPD responded to a physical fight in progress. Officers arrived on scene and located the victim a block away from the area with facial injuries. The suspect had punched and struck the victim with a hard case in the face. Officers located a potential suspect, positively identified him, and arrested him without incident.
- 10-07-2022- An unhoused person removed and stole two video cameras from a commercial building. Officers located the suspect and arrested him.
- 10-19-2022- MPD responded to a vehicle versus pedestrian on a bicycle traffic collision. AMR transported the bicyclist to a hospital for treatment. The roadway was closed while officers investigated the collision.

- 10-21-2022- MPD responded to a report of three suspects who entered a business, grabbed approximately \$60,000 in merchandise and fled. MPD disseminated the suspect vehicle information to surrounding agencies. The Marina PD located the suspect vehicle on Hwy1 and pursued the suspect, however the suspects were able to evade capture. The investigation is ongoing.
- 10-23-2022- MPD responded to a report of a subject who was chasing a person, swinging a knife at them all while yelling that he had a loaded gun and threatening to kill him. Officers located the suspect and arrested him.
- 10-24-2022- MPD officers responded to a report of a male suspect at a bar challenging people to fight. Two patrons physically detained the suspect. An MPD officer attempted to arrest the suspect, and the suspect punched the officer in the throat. Another MPD officer took the suspect to the ground and arrested the suspect without incident. Officers transported and booked the suspect at Monterey County Jail.
- 10-25-2022- MPD responded to a vehicle injury accident. It was determined a motorcycle was speeding between lanes of traffic and drove into a truck making a left turn. The motorcyclist suffered a head laceration and a possible broken hand. The road was closed in both directions for approximately 20 minutes while the MPD and paramedics attended to the injured motorcyclist and investigated the collision.
- 10-28-2022- An intoxicated subject drove the wrong direction in the Monterey tunnel and crashed into the curb and wall. MPD officers responded to the collision and arrested and booked the driver into jail.






Community Action Team (CAT)

- CAT obtained Inclement Weather Vouchers from the Monterey County Department of Social Services.
- MDOT Interim social worker provided an unsheltered female with a hotel voucher for three days.
- CAT assisted an unsheltered male with enrolling in the I-Help shelter program. He is now interested in entering a rehabilitation program with Sun Street Centers.
- CAT transported an unsheltered female experiencing a mental health crisis to the Gathering for Women, where they provided her with a shower and lunch.
- CAT assisted an unsheltered male with transportation from Sun Street Centers to the DMV to obtain a California identification card.
- CAT helped an unsheltered male pick up his medications at a local pharmacy.
- CAT provided an unsheltered male with transportation to I-Help for Men so he could enroll in their program.



Investigations / Monterey Police Anti-Crime Team (IMPACT)

- 10-05-2022- Detectives investigated a domestic violence and sexual assault case in Monterey.
 Detectives located and arrested the suspect in Seaside.
 Detectives forwarded the case to the District Attorney's Office.
- 10-11-2022- Detectives investigated a report of a school employee sexually annoying students. Detectives forwarded the case to the District Attorney's Office.
- 10-12-2022- Detectives investigated a sexual battery report. The investigation is ongoing.
- 10-14-2022- Two suspects stole two bikes in Monterey. Shortly after, MPD detectives located and recovered the bicycles and arrested the suspects.
- 10-19-2022- Detectives investigated a court order violation and intimidation of a witness after a suspect out on bail approached the victim. Detectives forwarded the case to the District Attorney's Office.
- 10-22-2022- Detectives learned of a suspect illegally selling guns in Monterey. Detectives served a search warrant on the suspect, and ultimately arrested the suspect for being a felon in possession of stolen firearms.
- 10-25-2022- Detectives investigated an arson case in Monterey. The investigation is ongoing.
- 10-25-2022- Detectives served a search warrant on a resident regarding possession of child sexual exploitation material.

- 10-25-2022- Detectives located a suspect wanted by the California Department of Corrections for a parole violation. Detectives arrested the suspect. The suspect was also a suspect in a sexual assault case in Monterey.
- 10-27-2022- A detective assisted in the investigation of an arson. Officers arrested the suspect. Detectives determined the suspect was not involved in other Monterey arson cases.
- 10-31-2022- Detectives served a search warrant related to a vehicle pursuit. Detectives arrested the driver and seized evidence.
- 10-31-2022- Detectives conducted a traffic stop on a bicycle. Detectives ultimately arrested the bicyclist for possessing a controlled substance and identity theft. Detectives seized Fentanyl.

Narcan Administered Lifesaving

 MPD and Monterey Fire responded to an unresponsive unhoused male. Monterey Fire administered Narcan to the subject and he regained consciousness. AMR transported the subject to CHOMP for further medical evaluation and treatment.



Case Study - John Doe 0922 / 0222 (October/ February 2022)

In an effort to explain some of the challenges faced by the MPD in trying to problem solve through a variety of ways, these case studies highlight aspects that the MPD and partners in MDOT face while attempting to resolve issues.

This month's case study is of a situation highlighted earlier in the year. John Doe 1022 was previously discussed in the February 2022 MPD Monthly Report as John Doe 0222.

- In October 2022, John Doe 0222 was arrested after the police had been called to Alvarado Street on three different occasions within an hour related to his challenging people. In one incident, officers determined no crime had been committed by Doe 0222. In the other prior incident, officers could not make an arrest without the victim's willingness to be involved. It is common for a victim to not want to participate because they would have to be willing to provide personal information and be prepared to attend various court hearings and testify against the subject.
- On the third call, Doe 0222 was challenging people in a local business and refusing to leave. Doe 0222 assaulted one victim and the victim struck Doe 0222 in self-defense. When the officer arrived and started to place Doe 0222 into custody, Doe 0222 punched the officer in the throat. Doe 0222 was taken to the ground and arrested. Officers transported Doe 0222 to the hospital to obtain a medical clearance before taking him to the jail for booking. Doe 0222 was booked for resisting an officer, assaulting an officer, trespassing and probation violation.
- The DA filed charges of battery on a peace officer, obstructing a peace officer, and interfering with a business. Doe 0222 was in custody at Monterey County Jail at the time this case study was written.



John Doe's 0222 original case study - February 2022

- John Doe 0222 is a 41-years old unhoused individual. While he is from Monterey, there is a stay away order prohibiting him from being at the family home. Since 2002, the Monterey Police Department has had 118 local contacts with Doe 0222. The contacts include arrests for violations of the law to include violation of protection orders, resisting arrest, drug possession and use, etc. Doe 0222 has also had multiple psychiatric evaluations.
- Doe 0222 is aggressive toward police officers when they contact him due his alcohol, drug and mental instability. Since 2020, Doe 0222 has been arrested (7) times for restraining order violations and been placed on a psychiatric evaluation (3) times. Since 2003, Doe 0222 has been placed on psychiatric evaluations (7) times. It is important to note that for a variety of reasons, arrests do not always result in criminal prosecution. At least four cases over a 16month period in 2020-2021 were dismissed. Doe 0222 was most recently arrested in February 2022.
- Doe 0222 is currently on probation with eighteen conditions for a case that occurred in 2020 for false imprisonment and criminal threats. He has one active case currently pending for violating a court order and drug possession. Doe 0222's probation conditions include things such as; obey all laws, not commit same/similar offense, not drink or possess alcoholic beverage, submit to search, etc.
- Doe 0222 is service resistant. MPD has continuously tried to obtain services for Doe 0222 and on one occasion, he was enrolled in a program, but opted out after a short period of time.



National Incident Based Reporting System

The Monterey Police Department (MPD) transitioned to the California and National Incident-Based Reporting Systems (CIBRS and NIBRS) on March 1, 2022 and has completed the required three (3) month validation period. CIBRS and NIBRS reporting meets state and federal data standards and supports the national transition to NIBRS. As the new data collection standard, NIBRS captures all offenses within an incident – up to ten crime occurrences, representing a substantial shift in crime reporting. The additional detailed crime incident data provides greater analytic capability and makes NIBRS a superior crime-reporting method when compared to the previously utilized Uniform Crime Reporting (UCR) standard. MPD has fully transitioned to NIBRS reporting and discontinued UCR reporting.

This new reporting yields a different format for data collection and is divided into Group A and Group B offenses. Group A offenses are the more serious crimes such as Murder, Rape, Robbery, etc. Group B offenses tend to be minor offenses, such as Curfew, Loitering and Vagrancy Violations, Disorderly Conduct, and Driving Under the Influence.

The data is grouped into three (3) crime categories of Crimes Against Persons (counted per victim), Crimes Against Property (counted per incident), and Crimes Against Society (counted per crime against society). Crimes against persons include assault, homicide, human trafficking, kidnapping and sex offenses. Crimes against property include robbery, burglary, larceny-theft, motor vehicle theft, and arson. Crimes against society include drug/narcotic offenses, gambling, pornography, prostitution, liquor law violations, disorderly conduct, peeping tom, curfew/vagrancy violations, trespassing, driving under the influence, and weapon law violations.

Law enforcement agencies report data from each offense and arrest for Group A offenses, but report only arrest data for Group B offenses. There are more offenses reported in NIBRS, more details per incident, and arrests and offenses linked in NIBRS.
