**CONTINUING DEVELOPMENT INCORPORATED TO OPERATE  
PRESIDIO OF MONTEREY (POM) CHILD DEVELOPMENT CENTER  
Meet & Greet, Thursday, November 21, 6:00 p.m.  
in the Council Chamber**

Monterey, CA. – The City of Monterey has secured a new NAEYC\*- accredited child care provider, Continuing Development Incorporated (CDI), at the Presidio of Monterey (POM) Child Development Center (CDC). The City of Monterey and CDI will host a Community CDC Meet & Greet on **Thursday, November 21, at 6:00 p.m.** in the Council Chamber at 580 Pacific Street in Monterey.

The Meet & Greet is an opportunity for families currently with children at KinderCare, as well as for new families with childcare needs, to meet the new provider and to learn more about both their Infant/Toddler Program as well as their Preschool Program.

“This important military-municipal-private partnership will continue,” said City Manager Hans Uslar. “I’m very proud of the work our team did to find another outstanding child care provider to provide this important service to our community, and in such a short time.”

The City received three competitive business plans from various child care providers interested in subleasing the space after the current sublessee, KinderCare,

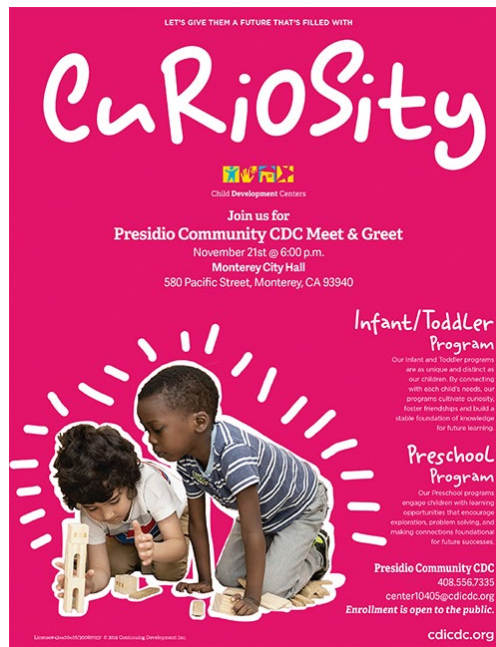

decided not to renew their sublease. The City leases the childcare facility from the Department of the Army and subleases it to a childcare provider. KinderCare has operated the facility for several years, and will close in mid-December.

The Child Development Center will re-open after facility improvements are completed and the State has issued a license for CDI to operate this facility. Enrollment is open to the public. CDI is a non-profit organization and operates over 160 child care centers throughout Northern and Southern California. They are headquartered in Morgan Hill.
